#### 2020 - Productivity Commission's Recommendations on Infrastructure Contributions New South Wales

#### Recommendation 2.1: Enhance efficiency of the infrastructure contributions system

Implement reform to deliver an efficient infrastructure contributions system so:

- local contributions are cost-reflective charges on impactors, applied through a consistent framework but with flexibility for adaptation to local circumstances
- state contributions are simple and certain charges on impactors and beneficiaries of State service delivery.

#### Recommendation 3.1: Allow councils' general income to increase with population

Subject to review by the Independent Pricing and Regulatory Tribunal, reform the local government rate peg to allow councils' general income to increase with population.

## Recommendation 4.1: Develop infrastructure contributions plans upfront as part of the zoning process

Amend legislation to require:

- where land is being rezoned, the draft infrastructure contributions plan must be publicly exhibited at the same time as the planning proposal
- adoption of the infrastructure contributions plan before any determination is made on a development application.

## Recommendation 4.2: Introduce a direct land contribution mechanism, to improve both efficiency and certainty for funding land acquisition

- i. Amend legislation to introduce a direct land contribution mechanism to:
  - apply a statutory charge on the land at the time of rezoning that requires a land contribution be made
  - require the contribution on sale of the land, or subdivision development application, whichever comes first
  - allow the contribution to be satisfied as a monetary payment, or dedication of land.
- ii. Consult with key stakeholders from councils and industry in the design and implementation of a direct land contribution mechanism.

## Recommendation 4.3: Issue advice for land valuation to improve consistency and accuracy

Develop a practice note, in consultation with the Valuer General, to guide land valuation, including assumptions and methodology, particularly for land that is yet to be rezoned and may be constrained.

#### Recommendation 4.4: Index land contribution amounts to changing land values

- The Valuer General prepare a methodology and publish appropriate land value indices
- ii. Amend legislation to require new contributions plans to separately identify and escalate land contribution amounts by the appropriate index.
- iii. The Minister to direct councils to separately identify and escalate land contribution amounts by the appropriate index when reviewing contributions plans.

#### Recommendation 4.5: Contributions plans use benchmarked costs

Independent Pricing and Regulatory Tribunal to develop and maintain standardised benchmark costs for local infrastructure that reflect the efficient cost of provision.

#### Recommendation 4.6: Contributions plans reflect development-contingent costs only

- i. Apply the essential works list to all section 7.11 contributions plans.
- ii. Independent Pricing and Regulatory Tribunal to review the essential works list and provide advice on the approach to considering efficient infrastructure design and application of nexus.
- iii. Subject to review by the Independent Pricing and Regulatory Tribunal, issue a revised practice note.

## Recommendation 4.7: Independent Pricing and Regulatory Tribunal review of contributions plans be 'by exception' and based on efficient costs

- Remove the monetary trigger for review of contributions plans by the Independent Pricing and Regulatory Tribunal.
- ii. Develop Terms of Reference for the Independent Pricing and Regulatory Tribunal to review any costs in a section 7.11 contributions plan on a 'by exception' basis with the option of a 'targeted' review of specific sections of a plan.
- iii. Prepare a practice note to reflect the 'by exception' review process and requirements for local contributions plans.

## Recommendation 4.8: Contributions plans are prepared using standard online templates and digital tools

- Develop standard online contributions plan templates for section 7.11 local contributions and section 7.12 fixed levies.
- Amend legislation to require new contributions plans be made using standard templates and housed within the contributions digital tool to be developed on the NSW Planning Portal.
- iii. Require contributions plans transition to the digital tool upon review.

## Recommendation 4.9: Encourage councils to forward fund infrastructure, through borrowing and pooling of funds

- i. Amend legislation to allow:
  - · pooling of contributions funds as the default option
  - interest costs associated with borrowing for infrastructure be collected through contributions plans.
- ii. Incentivise councils to borrow to forward fund infrastructure, including by:
  - Treasury Corporation reviewing their lending criteria to consider allowing capital
    grants and contributions (including infrastructure contributions) to be included in
    debt serviceability calculations where contributions relate specifically to the
    project for which council is seeking funding
  - establishing a program to provide an additional financial incentive when councils borrow to build infrastructure.

## Recommendation 4.10: Defer payment of contributions to the occupation certificate stage

- Extend permanently the Environmental Planning and Assessment (Local Infrastructure Contributions – Timing of Payments) Direction 2020 that was introduced as a temporary measure in response to the COVID-19 pandemic.
- ii. Design the NSW Planning Portal so that the release of occupation certificates is contingent upon payment of infrastructure contributions.
- iii. Increase oversight of private certifiers by requiring that the certifying authority must confirm payment of contributions before issuing an occupation certificate.
- iv. Amend legislation to create an offence should certifiers issue a certificate without an infrastructure contribution payment.

## Recommendation 4.11: Increase the maximum rate for section 7.12 fixed development consent levies

- Amend the maximum rate for section 7.12 contributions as follows:
  - \$10 000 per additional dwelling for houses (detached, semi-detached, townhouses)
  - \$8 000 per additional dwelling for all other residential accommodation
  - \$35 per square metre of additional gross floor area for commercial uses
  - \$25 per square metre of additional gross floor area for retail uses
  - \$13 per square metre of additional gross floor area for industrial uses.
- ii. Index contribution rates quarterly using the Producer Price Index (Road and Bridge Construction – NSW) and review periodically (approximately every three to five years) to ensure they remain in line with the intended proportion of development costs

## Recommendation 4.12: Planning agreements consistent with the principles-based approach

- Adopt the Draft Planning Agreements Practice Note 2020 and EP&A Regulation amendments exhibited by the Department in April 2020to provide immediate improvements to the operation of planning agreements.
- ii. Amend the practice note to embed the principles of the contributions system, so that planning agreements are:
  - for the delivery of infrastructure to support development that is out-of-sequence or unexpected
  - to facilitate the direct delivery of development-contingent infrastructure or impact mitigation works.
- iii. Amend the legislation to require planning authorities to:
  - register planning agreements and draft planning agreements in a centralised system, contained within the NSW Planning Portal
  - 'publicly exhibit' rather than 'publicly notify' planning agreements, including requirements to receive and consider public submissions.

## Recommendation 4.13: Publish guidelines for planning agreements for mining and energy related projects consistent with the principles-based approach

Publish a guideline for mining and energy related projects consistent with the principlesbased approach, so that planning agreements primarily relate to direct delivery of development-contingent infrastructure.

#### Recommendation 6.1: Develop and implement a centralised contributions digital tool

- i. Develop a contributions digital tool in the NSW Planning Portal, integrated with the spatial mapping and development application system, which:
  - · requires councils and the State to make contributions plans
  - · receive and track payments
  - report on contributions spending, fulfill accounting requirements, and report on the infrastructure delivery pipeline
  - allows landowners and developers to estimate, calculate, and pay their infrastructure contributions for both local and state infrastructure in one place, ideally in one payment.
- ii. Amend legislation to support the digital tools and require their use to be phased in.

#### Recommendation 6.3: Build the capability and expertise of the planning sector

- Create and maintain consolidated guidance material for each contribution mechanism that reflects up-to-date information and integrates with the digital tool.
- ii. Implement a training and professional development program to support planning practitioners and build a knowledge sharing culture within the planning system.

#### Recommendation 6.4: Introduce a simple, clear, standardised exemptions policy

Produce a simple, clear, standardised exemptions policy, underpinned by guiding principles, to ensure a consistent and transparent application of exemptions.

## Recommendation 6.5: Better synchronise State and local strategic planning frameworks

- Amend legislation to update the review timeframes of Local Strategic Planning Statements to five years, in line with other State and regional plans.
- ii. Issue a Ministerial direction extending the regional implementation plan timeframe to cover a 4-year period to align with councils' delivery program.

## Recommendation 6.6: Incorporate the local infrastructure contributions system into the Integrated Planning and Reporting framework

Update the Integrated Planning and Reporting Framework to require councils to:

- · include infrastructure contribution plans in their reporting
- review their infrastructure contributions plans by 1 July 2024, and every four years thereafter (or earlier if required), to align with their delivery program.

#### Recommendation 6.7: Strategic planning to maximise the efficient use of land

- Issue a Ministerial Direction to require planning proposals to demonstrate consideration of efficient use of land, including opportunities for dual-use and jointuse.
- Develop a practice note to establish performance-based benchmarks for open space planning.

The committee confirms that the minutes from the meeting of the committee held on 20 October 2020 be accepted.

#### 3. Business arising from previous minutes

a) Federal Hwy Service Road – Hoon Behaviour At the October 2020 LTC meeting the NSW Police representative requested assistance from Council to help address 'hoon' behaviour on the Federal Hwy Service Road that has proven difficult from an enforcement perspective. A site inspection with Council and Police was held on 26 November 2020. Council is developing options aimed at kerbing the behaviour and has also sought advice from TfNSW, options may include jersy barriers and the like.

#### 4. Business Items

#### a) Anne St – School Zone changes

Council's rangers have reported an issue with location of a 'No Stopping' sign in Anne Street school zone. The sign is located on school side, to east of the school's driveway exit and within 3.5 metres of a residential driveway. There is some space that could be used for vehicle parking (if precisely parked) but the space is small enough to be problematic for both drivers and rangers. Larger vehicles park and over-hang into the 'No Stopping' area or the residential driveway and drivers report being unclear if they can park in this area. The small space available for parking also attracts other vehicles to try and park in the 'No Stopping' area — residents across from the 'No Stopping' area have raised with Council the non-compliant parking behaviour and difficulty accessing their driveway when vehicles are illegally parked.

To provide clear direction on the parking requirements in this area and to assist with safety and compliance Council is proposing to relocate the 'No Stopping' sign east by 3.5m to edge of the driveway. This would establish this stretch of road as 'No Stopping' area, assist in visibility of the school's driveway exit which is near the children's crossing and would assist in the safety concerns of residents. While the location of this signage was reviewed, Council also proposes to install Children Crossing Ahead signage as per design.

LTC 45/2020 PROPOSED SOLUTION: Under Road Transport Act 2013 approve the revision to the no-stopping signage and children crossing ahead on Anne St, Queanbeyan as per the design.

### Terms of Reference QPRC Access Committee

At the Council meeting of 24 May 2017, Council adopted a Disability Inclusion Action Plan. One of the Key Actions identified in this Plan is to 'establish an Access Committee'. The purpose of a QPRC Access Committee is to provide informed advice to Council on the development, implementation, monitoring and review of policy, strategies and plans to advance the accessibility of the area and the inclusion of people with a disability.

#### 1. Role

The role of the committee is to:

- Assist Council to identify and remove barriers preventing the participation of people with disability in the life of the Queanbeyan-Palerang LGA.
- Identify issues of concern and impacts relating to people with disabilities living in Queanbeyan-Palerang
- Provide advice to relevant sections of Council on matters of access and inclusion of people with disability.
- Advise and make recommendations to Council on matters relating to access for people with disabilities to Council facilities and services and within the community generally.
- Input into the development of strategies to increase access and inclusion within the Queanbeyan-Palerang LGA.
- Oversee the implementation and review of actions identified in Council's Disability Action Plan.

#### 2. Membership

- Membership of the committee will consist of a minimum of six members, with a maximum of 12 living in areas within the Queanbeyan Palerang LGA.
- Members will be appointed by existing Committee members and ratified by Council.
- Members will include the following:
  - One Councillor who will act as Chair (currently Councillor Kenrick Winchester)
  - A balanced mix of members comprising people living or working with a disability or family members/carers of those living with disability from within the LGA
  - Service providers in the field of disability/inclusion are welcome to participate in committee meetings as non-voting observers (maximum 2)
- Relevant QPRC staff will attend meetings as deemed appropriate by the Service Manager, Community & Education to provide advice to assist

1



with the Committee's deliberations.

- Membership of the committee will be determined every two years, with the exception of Councillor Representatives who will be appointed every September.
- Members are appointed in an individual capacity based on skills and experience and not as representative of a particular group.
- A person ceases to be a member if they:
  - resign;
  - are absent for more than two consecutive meetings without notification;
  - o fail to follow these Terms of Reference
- Any member may resign by giving written notification to the Council. The Council may appoint a new member on consultation with existing committee members.

#### 3. Selection of Committee members

- Membership of the Committee will be achieved through an expression of interest via public advertisement through local media channels.
- Applicants will be asked to email a nomination form to Council outlining their interest in any areas pertaining to disability and inclusion and declare no conflict of interest.
- People with disability from diverse backgrounds are encouraged to apply. This
  includes; young people, older people, people from socio-economically
  disadvantaged backgrounds, people from culturally and linguistically diverse
  backgrounds, Aboriginal and Torres Strait Islander people and gay, lesbian,
  transgender and bi-sexual people.

#### 4. Meeting administration and protocol

- The QPRC Access Committee is convened by Council's Service
  Manager, Community & Education or delegated officer who will attend
  meetings as a resource person and will be responsible for taking and
  distributing minutes, coordinating the agenda, inviting relevant Council
  officers to attend, arranging the meeting venue, organising refreshments,
  and coordinating any assistance required by members (with disability) to
  participate.
- Meetings will be held on a quarterly basis unless otherwise determined by the Committee at its inaugural meeting.
- The quorum for the Access Committee meetings will be a simple majority.
- No business of the Committee will be considered unless a quorum is present. Attempts to reschedule the meeting to achieve a quorum will be made.
- Questions arising at any meeting of the Committee will be decided by a simple majority of the votes of the members. Council staff have no voting right.



- Minutes of the Committee will be reported to Council for endorsement (except when a quorum is not achieved).
- If the chairperson is not present ten minutes after the time appointed for the meeting, the members may choose one of their numbers to act as chairperson for the purpose of the meeting.
- Members must act lawfully, professionally, with honour and integrity.
   Information accessed, discussed, received, and used in meetings is confidential unless the Committee resolves otherwise.
- QPRC, through resolution by Council, may terminate an Access Committee member's term for breaching the confidentiality rules.
- A member who has a pecuniary interest in a matter being considered at a
  meeting must disclose the existence and nature of the interest. A
  member having disclosed a pecuniary interest must not be present at the
  meeting when the matter is being considered, discussed, or voted on.
- A member who has a non-pecuniary interest in a matter being considered must disclose the existence and nature of the interest if the member could be influenced or perceived to be influenced by the non-pecuniary interest. A member having disclosed a non-pecuniary interest must not be present at the meeting when the matter is being considered, discussed, or voted on.

#### 5. Review

 Recommendations for amendments to the Terms of Reference can be made at any time. However, amendments to the Terms of Reference must first be endorsed by the Access Committee and then approved by Council.

# Transport for New South Wales South Region

November 2020



### 1 Summary

Transport for New South Wales is currently working on 14 major infrastructure projects. There are:

- · Ten proposals in development
- Four projects currently under construction

### 1.1 Proposals in development

- Princes Highway Upgrade Program
- M1 Princes Motorway improvements
- . M1 Princes Motorway interchange at Mount Ousley
- Nelligen Bridge replacement on the Kings Highway
- Princes Highway and South Batemans Bay Link Road intersection project

#### 1.2 Projects in construction

- Albion Park Rail bypass
- Berry to Bomaderry upgrade
- Nowra bridge
- Batemans Bay bridge

#### 1.3 Completed projects

- Ellerton Drive extension, Queanbeyan (in conjunction with Queanbeyan Palerang Regional Council)
- Charleyong Bridge replacement (in conjunction with Queanbeyan Palerang Regional Council)



### 2 Proposals in development

#### 2.1 Princes Highway Upgrade Program

Transport for New South Wales is planning upgrades along the Princes Highway between Jervis Bay Road and the Victorian border.

The Princes Highway Upgrade Program was officially launched on the 16 March 2020.

Projects in development under the Princes Highway Upgrade Program include;

- · Jervis Bay Road and Princes Highway Intersection upgrade at Falls Creek
- Duplication sections of the Princes Highway between Jervis Bay Road and Sussex Inlet Road
- Milton Ulladulla bypass project
- · Upgrades of the Princes Highway between Burrill Lake and Batemans Bay
- Moruya bypass

On the 25 November the Princes Highway Strategic Roadmap 2040 was released as well announcements of a preferred option on the Jervis Bay Road intersection upgrade and preferred strategic corridors for the Jervis Bay Road to Sussex Inlet Road upgrade and the Milton Ulladulla bypass project. Consultation closes 20 December 2020.

#### 2.2 M1 Princes Motorway improvements between Picton Road and Bulli Tops

Transport for New South Wales is planning upgrades to the M1 Princes Motorway between Picton Road and Bulli Tops. The upgrades will improve road safety, travel times and efficiency.

The detailed design work for stage one improvements on the M1 Princes Motorway between Picton Road and Bulli Tops has been completed.

There have been no major changes since the concept design was displayed.

We will continue to keep the community and stakeholders informed as the project progresses.

A review of environmental factors for Stage 1 of the project between Picton Road and Bellambi Creek was exhibited in December 2016. In June 2017, a Submissions Report was published in response to the display of the environmental assessment for the first stage of the project.

#### 2.3 M1 Princes Motorway interchange at Mount Ousley

Transport for New South Wales is planning for an interchange on the M1 Princes Motorway at the base of Mount Ousley. The project would replace the existing at grade intersection of the M1 and Mount Ousley Road.

The Review of Environmental Factors and concept design was put on display in November 2017. A Submissions Report was published in April 2018 that addressed feedback from the community during the consultation period last year and has proposed a few design changes. It considered additional consultation that took place around noise management during and after construction.

The project has achieved planning approval. Subject to funding, the next stage will be to prepare the detailed design for the project. Timing and funding for construction of the interchange upgrade is still to be confirmed.

### 2.4 Nelligen Bridge replacement, Kings Highway

Transport for New South Wales is planning to replace the existing Nelligen Bridge with a new bridge upstream to ensure a safe and reliable crossing on the Clyde River, and to improve road safety and traffic efficiency on the Kings Highway.

Early work on the Nelligen Bridge replacement, including earthworks, was completed in mid-April 2019.

Utility relocation work has been completed.

#### 2.5 South Batemans Bay Link Road project

Transport for New South Wales is planning for a safe and efficient connection between the South Batemans Bay Link Road and the Princes Highway.

The project will take pressure off Beach Road, relieve congestion in the Batemans Bay CBD and support future growth.

Transport for NSW has finalised the environmental assessment and developed a concept design for the proposal. Feedback was sought on the Review of Environmental Factors and the concept design to the 24 May 2020.

Transport for NSW released a submissions report in August 2020 which summarises the feedback and provides responses to all issues received during the public display of the REF.

#### 2.6 Hume Highway Pavement Rehabilitation at Marulan

Transport for New South Wales is continuing planning for the rehabilitation of sections of the Marulan bypass on the Hume Highway, north of Goulburn.

Tenders for the supply of material for the pavement rehabilitation closed October 2020.

The rehabilitation will involve the recycling and replacement of the existing rigid concrete pavement with a flexible pavement.

Benefits of the project include reducing ongoing road maintenance costs and requirements, and providing a smoother driving experience for motorists.

The project is funded by the Australian and NSW governments.



### 3 Projects in construction

#### 3.1 Albion Park Rail bypass, Princes Highway

Transport for New South Wales is upgrading the M1 Princes Motorway between Yallah and Oak Flats to bypass Albion Park Rail. The bypass would complete the 'missing link' for a high standard road between Sydney and Bomaderry.

In July 2018, the design and construct contract for the Albion Park Rail bypass was awarded to Fulton Hogan.

The Croom Regional Sporting Complex was officially opened on the 10 August 2019 marking an important milestone for the project.

Since the last SEATS report we have:

- · opened the new Croome Road bridge
- commenced reusing up to 6000 tonnes of recycled glass sand in the pavement base layers.
   The asphalt will include 10 per cent recycled glass and 15 per cent reused asphalt.
- prepare the opening of another section of the East West Link between Durgadin Drive and the Oak Flats interchange. This planned to be opened from 3 December 2020, weather permitting

In the coming months we will be:

- continuing with pavement construction, laying asphalt and line marking
- opening another section of the East West Link
- continuing with bridge work including installing 31 bridge planks on the final bridge
- continuing with drainage, signage, street lighting, traffic signals and barriers
- landscaping and revegetating.

Construction of the bypass is expected to be completed from mid-2021, weather permitting.

#### 3.2 Berry to Bomaderry Upgrade, Princes Highway

Transport for New South Wales is upgrading the Princes Highway between Berry and Bomaderry. The \$450 million project will improve safety, increase road capacity, improve traffic flow and deliver better and more reliable journeys on this section of the highway.

The construction contract for the highway upgrade project was awarded to Downer/ Seymour Whyte Joint Venture and major work started in September 2018.

Four lanes of new divided road between Mullers Lane at Berry and the Cambewarra Road roundabout at Bomaderry will be built.

Traffic was moved onto new sections of highway between Ison Lane, Jaspers Brush and Abernethys Lane, Meroo Meadow in October. These changes included the full opening of the Pestells Lane

overpass at Meroo Meadow.

The Meroo Road/Princes Highway intersection is temporarily closed from October until December 2020 to allow for the upgrade of the old highway at this location. During this time, access between Meroo Road and the Princes Highway will be via the new Pestells Lane overpass, from the western side of the highway.

The project is scheduled for completion in 2022.

#### 3.3 Nowra Bridge, Princes Highway

The NSW and Australian Governments are funding a new four lane bridge over the Shoalhaven River, upgraded intersections and additional lanes on the Princes Highway.

The \$342 million project will improve traffic flow and ease congestion on a major section of the Princes Highway and deliver safer and more reliable journeys within the Nowra-Bornaderry area.

Major work on the Nowra Bridge project officially started with a turning of the first sod on 19 June 2020. The first sod was turned by Australian and NSW Government representatives on the southern foreshore of Nowra where the new bridge will be constructed and pushed out into its final position.

Major work is now underway and an exclusion zone has been established within the Shoalhaven River to enable work to occur within the waterway. A temporary working platform has been built from the southern foreshore. Bridge piling work is about to commence. We will start on the southern bank of the river and then move along the temporary rock platform and into the river. Pilin is expected to be completed by late 2021, weather permitting.

Other work planned over the coming months will include:

- · Continuing vegetation removal in work areas and utility relocations
- · Continuing work on the new local road connecting to Lyrebird Drive
- Building the casting yard on the southern side of the Shoalhaven River, where the concrete bridge segments will be made
- Removing material including rock from the work area near Illaroo Road
- Closing car parking spaces on Illaroo Road
- Removing the median islands and building temporary pavement north of Bolong Road
- Widening the Princes Highway on the north western side of Bomaderry Creek.

Major work started in mid 2020 and the project is expected to be complete by mid 2024.

#### 3.4 Batemans Bay Bridge

The \$274 million project will build better connections in and around Batemans Bay for motorists, freight, river users, pedestrians and cyclists.

Major work started in early 2019 and is planned to be complete in early 2023.

A major milestone was achieved in November 2020 with the placement of the final segment on the bridge.

Other work planned to the end of the year includes:

- carrying out finishing works on northern and southern bridge approach retaining walls and embankments
- · commencing bridge finishing works such as installation of barriers and the road surface
- temporarily opening new Wharf Road of ramp from Princes Highway and opening new Wharf Road roundabout
- · continuing preparation work for new L-shaped floating pontoon on the southern foreshore
- working with the Public Art Advisory Committee to engage an artist for a public artwork on the southern foreshore.

### 4 Completed projects

#### 4.1 Ellerton Drive extension, Queanbeyan

The \$86 million Ellerton Drive extension project was officially opened to traffic on Friday 10 July.

The Australian and NSW governments each committed \$25 million towards the project while Queanbeyan-Palerang Regional Council committed \$36 million. The 4.6 kilometre road provides an alternative route around the Queanbeyan CBD to the new southern population growth areas.

#### 4.2 Charleyong Bridge replacement

Transport for NSW has built a new Charleyong Bridge over the Mongarlowe River, Charleyong. The bridge is located on Main Road 92 connecting Braidwood and Nowra via Nerriga. The project was jointly funded, with the NSW Government allocating \$18 million and the Australian Government allocating \$5 million for the project. Funding for the project forms part of the NSW Government's Bridges for the Bush Program.

The new Charleyong Bridge was officially opened on Monday 9 March.

Demolition of the existing timber bridge is expected to start in early 2021 after the Macquarie Perch spawning season with completion expected by mid-2021.

- Scope: Undertake the detail design and ultimately the construction of the extension of Morisset Road from Flemington Road to the Federal Highway.
- The project has a business case in for consideration. Construction costs are estimated at \$35million.

- Aim: Duplicate the remaining 4.5km section of William Hovell Drive. The Investment Logic Workshop for the project highlighted this as being a major east / west arterial road corridor and the duplication would provide significant transport efficiencies.
- Scope: Undertake the detail design and ultimately the construction of the duplication of William Hovell Drive from Drake-Brockman Drive to John Gorton Drive.
- The project has a business case in for consideration. Construction costs are estimated at \$61million.

### Dargues Reef Community Consultative Committee

Cr Harrison, Site Visit 30 November, Meeting 14 December 2020

A site visit was organised in conjunction with the December meeting to allow committee members to inspect elements of the processing plant that were not operational at the time of the previous visit, the primary crusher in particular, since this has been the source of most community concern in relation to noise emanating from the mine site.

One of the most significant developments since the last meeting was the acquisition of the Dargues Gold Mine by Aurelia Metals. This change in 'ownership' will not change some aspects of the mine's operations, however, as Pybar Mining Services, the parent company of the previous owner, Diversified Minerals, will continue as the underground mine contractor. Some of the details of the new owner are provided in the most recent Newsletter, included as Attachment 1 to this report. The Newsletter also provides an update on mine operations, the company's Scholarships and Community Grants Programs.

In addition to the regular updates covered in the presentation material provided as Attachment 2 to this report, two issues in particular dominated discussion.

The first was the [lack of] response from DPIE in relation to issues raised, and discussed with them, at the June meeting. The Committee was of the understanding that DPIE would report back on the status of their investigations by the end of July. DPIE representatives, however, have subsequently sought to clarify their position, that being that there is no commitment on their part to formally advise the Committee of either the progress of or the ultimate outcome of their investigations. Details will be provided through DPIE's normal channels of communication.

The second was in relation to commentary that the mine operator was investigating the option of 24 hour operation of the crusher circuit, which does not normally operate at night. This has been of some concern to the Majors Creek community, as the crusher is the main source of unwanted noise emanating from the mine site, even when operating below EPA-mandated noise levels. The mine license allows for 20 days of 24 hour operation [of the crusher circuit] per year, but the operator explained that the investigations were intended to explore the parameters within which 24 hour operations might be practical—certain weather conditions, for example, are not conducive to noise suppression. Given that the mine license only permits the extraction of a specific amount of ore per year, and this can easily be accommodated within the current operating regime, 24 hour operations of the crusher would only ever be considered if there had been an unforseen plant interruption that resulted in a significant fall in production.
