# Majara St Road Closure, Bungendore

#### **Executive Summary of engagement report:**

Following a Council resolution on 28 October, Council sought public comment on the proposal to close

- a) the section of Majara Street roadway bounded by Turallo Terrace and Gibraltar Street, an area of approximately 6,025 sqm; and
- b) the road reserve north of Turallo Terrace to the river corridor.

In the notification (see below), Council advised that


- When the section of road reserve north of Turallo Terrace (B) is closed, the land will be classified as operational. The area shown in light blue in the diagram is the proposed site for Abbeyfield Bungendore House.
- Council intends to dispose of the Majara Street road reserve land by sale.

A Notice identifying the proposed area to be closed (see below) inviting submissions to the proposed road closure was published in the Regional Independent on 3 and 17 February 2021. The Notice was also published on Council's Your Voice webpage on 3 February 2021.

In addition, the Notice was sent by post (or email) to the nominated addresses of Notifiable Authorities (defined under section 32B of the Roads Act), adjoining land owners and to the property owners along Gibraltar and Turallo Terrace adjoining the Mick Sherd oval.

There was a 28-day submission period and Council received a total of 171 submissions, copies of which are annexed to this report. Council has prepared responses as outlined in attached Engagement Report.

#### Report - Community Engagement – Majara Street Closure - Bungendore

**Proposed closure of** Majara Street, Bungendore

Under the provisions of the Roads Act 1993, notice is hereby given that Queanbeyan-Palerang Regional Council proposes to close the Council public road listed below and indicated by the red hatched areas in the adjacent diagram:

- (A) the section of Majara Street roadway bounded by Turallo Terrace and Gibraltar Street, an area of approximately 6,025 sqm; and
- (B) the road reserve north of Turallo Terrace to the river corridor.

When the section of road reserve north of Turallo Terrace (B) is closed, the land will be classified as operational. The area shown in light blue in the adjacent diagram is the proposed site for Abbeyfield Bungendore House.

Council intends to dispose of the Majara Street road reserve land by sale.

#### Participation in engagement:

During the consultation period, Council received 171 submissions.

- 49 submissions via email directly to Council (Submissions 1-49), and
- 122 submissions were submitted via Your Voice (Submissions 50 171)
- The project page on Your Voice had 888 visitors with 202 of these visiting on 25 February 2021.

#### Comments received:

During the exhibition period, submitters raised a number of matters which staff have responded to below. Many of the submissions provided via email are lengthy and have been attached to the Council report and are referenced in the table below.

Many of the matters raised in the public submissions are outside the scope of this engagement process, that being solely on the closure of Majara Street. Consequently, and as highlighted in the responses below, many of the matters raised will be considered during the development application process that will be undertaken by the Department of Education.

1.5	Current traffic on Turallo Terrace and Butmaroo St	Council regularly collects traffic data on local roads. In regards to Majara St, the following data has been collected in recent years
		Recorded October 2017 Majara St – south of Turallo Terrace to QPRC office – 931 ADT. It is anticipated that one third of these trips were undertaken by those accessing Council's building or the Bungendore pool, both of which will not be located in this area in the future.
1.6	Impact on parking in area	The closure of Majara St will remove parking that faces on to Mick Sherd Oval and parking outside of the current Council building. The new high school in Bungendore proposal includes car parks behind the existing Palerang Council Building. The car parks would be used by teachers during school hours. Additional Parking will be formalised on Turallo Cres and within the Train Station Grounds for the utilisation of all users. DoE is finalising the transport strategy for the high school. This will outline the number of car parks included in the development. It is noted that Parking provision will be paramount to the safe success of the proposal.
1.7	What is Council doing with the proceeds from the closure and sale of the road and other properties?	All proceeds from the sale of Council assets in Bungendore will be spent within the Bungendore community. Council has accepted a financial proposal aligned with the Bungendore High School proposal. As part of this, funding is allocated for the construction of the new pool at the Sports Hub, maintenance of Mick Sherd Oval, construction of a new integrated customer centre and community library, a new community centre, and construction of a new office for Bungendore staff. The new pool is estimated to cost \$10m, of which Council will be provided within \$5m by the DoE. The additional funding required for the pool will be sourced via loans and has been incorporated into Council's Long Term Financial Plan Council is considering its options for the new Bungendore office and may progress plans to house all Bungendore staff, including customer service and the library in the same building. Council has resolved to negotiate with three landowners regarding a site and

The full traffic assessment will be made publicly available as part of the development application process. DoE has released a summary. The proactive release of the full document is a decision for DoE. Councillors have been provided with a confidential copy of the assessment to assist with their decision making process.

1.16	Parking at Frogs Hollow	The closure of Majara St and the Frogs Hollow redevelopment are different projects and are not linked. Council sought community comment on some concept plans for Frogs Hollow. These plans included some public car parking.
1.17	Access to other areas of Bungendore	The closure of Majara St would require alternate routes to be taken to access different parts of Bungendore. The currently proposal from DoE includes a roundabout at the corner of Butmaroo and Gibraltar Sts to assist with traffic movements.
1.18	What is the intent of the new road behind the current Council building?	DoE is proposing to construct a new road between the existing Council building and the railway line to provide access to the car park, for buses and deliveries. Council understands that this new road is not being constructed as a replacement for Majara St.
1.19	What access will there be to the new school?	This is outside the scope of this engagement process, however DoE has advised in recently released frequently asked questions that further studies will be done to information their development application. These studies will include pedestrian footpaths, bus bays, parking and kiss and drops to both the primary and high schools.
1.20	What do you mean when you say the land near the river will be classified as operational?	The land is currently classified as 'community' meaning that a building such as that required for Abbeyfield would be unable to be built on the land under the <i>Local Government Act 1993</i> . By changing the use of the land to 'operational' under this Act, a development such as Abbeyfield would be able to proceed, following appropriate development assessment.

		Council was approached with a proposal to construct a school on Mick Sherd Oval and to acquire the Council-owned property on Majara St. A workshop was held with Department of Education representatives, councillors and staff in July 2020. During the workshop, there was discussion on minimising the impact on Mick Sherd Oval as much as possible. It was suggested during the workshop that moving the school further to the east, and utilising the road reserve may be worth consideration by DoE. This was a suggestion, not a decision or a direction. DoE representatives took the suggestion on board and revised the plan following consideration.
		There will be no impact on the dog off lead area, even with the construction of Abbeyfield. The dog off lead will remain operational and accessible for members of the community.

Heritage: There is significant and long standing items of considerable heritage value to the town in this area. The school of art, police station, indigenous gravesite, train station and Bungendore park are all but a few of the assets with great value for our town. The oval, home to the Bungendore Tigers since 1908, is on Bungendore Park. Bungendore Park was gazetted in the mid 19th century (1800s) as a recreation space for Bungendore. Currently that piece of land is used as an informal/unsealed and sealed carpark for the Scout Hall, the preschool and the off leash dog area. Removing these amenities will require user groups to park in the proposed new carpark on the opposite side of Turallo Tce noting that this car park is only being proposed for use outside of school hours. If this proposal is approved and goes forward, youth and parents and recreational users of the off leash area will need to cross an increasingly busy road without any pedestrian infrastructure to assist. I am writing to object to the permanent closure of Majara Street in Bungendore so that the space can be re-purposed for high school buildings and other related amenities.

The current plan makes little sense; much better sites for a high school exist in and around the town.

But, specific to the road closure, there are many problems with this proposal.

## Where has the Historic Nature of Bungendore Park and Surrounds Been Referenced in These Plans?

Majara, Gibraltar and Butmaroo Streets, and Turallo Terrace, surround Bungendore Park which is the oldest dedicated recreational space in our town, dating back to 1886. The park is used by many different people and there is always something going on there, from children playing in the playground to tennis to swimming to folks using the outdoor gym to footie training to kite-flying, and much more. When I described the Dept. of Education School Infrastructure plans to a local professional historian, they commented that they thought the community would be up in arms at losing so much of their public park!

However the Dept of Education has managed to put spin on the story to the extent that many residents have been soothed into thinking that not much will change. And Bungendore has a history of protesting against the loss of community assets to no avail.

There are two stone memorials in the park (the cenotaph and the water fountain). They are just two of the many heritage items (some listed, some not) which together make up an important heritage precinct in Bungendore. The items include the Courthouse (1864), old stables (oldest building in the village dating to 1847, currently being restored), Public School (1879), School of Arts (c.1890), old convent (1886), Railway Station and cottages (1885), and Post Office (1892).

This handsome assembly of 19th Century architecture makes our town distinctive. I have seen the loss of many old buildings and rustic features in Bungendore and the time has come to take stock of remaining built heritage and protect it. Closure of the street and erection of modern two-storey buildings, surrounded by concrete carparks, on what was green open space, will have the opposite effect.

Document Set ID: 1096429 Version: 1, Version Date: 04/02/2021 Not so long ago, a QCC bid to transform the Queanbeyan Showground into a high-density housing estate was successfully resisted by local residents. Surely Bungendore deserves to escape this similar imposition on our communal assets!

#### Where is the Traffic Study?

Blind Freddie could see that if Majara Street is closed there will be major disruption to traffic flow. The historic grid pattern which persists in old Bungendore makes for calm, efficient traffic flow and residential streets remain comparatively quiet compared to major thoroughfares such as the Kings Highway. These changes will result in heavy traffic through residential streets, which will only continue to increase as new housing estates such as Elmslea North are developed. Traffic movement around the school, pre-school, playground, pool, scout hall and the new Abbeyfield building once built will substantially increase. Children and the elderly are the most vulnerable groups in society when it comes to pedestrian accidents.

I would appreciate seeing how the Council plans to accommodate the needs of all Bungendore people, rather than just high school students and staff.

In short, Council must allow residents to view heritage and traffic studies that show how the building of the high school will protect and enhance our precious historic precinct and our safe streets.

# Closing part of Majara Street will have a detrimental effect on the whole central section of our town.

Partially closing a road that is integral to the amenity of the centre of our town is very short sighted and can not be a long term solution for future developments. A full traffic study and a heritage assessment of this precinct should precede any decision to close this road.

The grid pattern that was adopted for the heritage part of Bungendore is simple and structured to enable ease of navigation by residents and visitors. Majara Street, between Turallo Terrace and Malbon Street, is a main thoroughfare for residents of Elmslea to access all the amenities of the town and by closing this road all traffic will be diverted down Turallo Terrace past the Preschool and then onto either Butmaroo or Ellendon Streets which are predominately residential. The traffic from the proposed developments to the north of Elmslea will also feed into McCusker Drive which will then add further volume to the current traffic.

I acknowledge receipt of your letter dated 3 February 2021 notifying Council's proposal to partially close a council's public road at Majara Street (**Proposal**) together with Diagram provided.

It is noted that Council intends to dispose of the Majara Street road reserve marked A by sale and a section of the Road Reserve north of Tarallo Terrace marked B will be closed and classified as operational.

As you can see below, those areas marked A and B respectively are adjacent to the operational rail corridor from Tarago to Queanbeyan (marked in green) forming part of the Country Regional Network (CRN).

As of 15 January 2012, John Holland Rail (JHR) have been appointed to manage the CRN and the lands containing the CRN. As such, JHR is responsible for reviewing the proposal to close roads adjacent to rail corridors to ensure that potential impacts to rail operations (current and future) are considered and addressed.

Upon review of the Proposal, I advise that the proposal does not have any consequential impacts on the rail corridor.





# Proposed Closure of Majara St Bungendore

Closing part of Majara Street will have a long lasting and irrevocable detrimental effect on the whole central section of our town, and indeed its heritage.

The proposed partial closure of a road that is integral to the amenity of the centre of our town is extremely short sighted by QPRC and cannot nor should be considered a long-term solution for future developments. A full traffic study and a heritage assessment of this precinct should and must precede any decision to close this road.

The grid pattern that was adopted for the heritage part of Bungendore is simple and structured to enable ease of navigation by residents and visitors. Majara Street, between Turallo Terrace and Malbon Street, is a main thoroughfare for residents of Elmslea to access all the amenities of the town and by the proposed closure of this section of Majara St will see all traffic being diverted down Turallo Terrace past the Preschool and then onto either Butmaroo or Ellendon Streets which are predominately residential. The traffic from the proposed developments to the north of Elmslea will also feed into McCusker Drive which will then add further volume to the current traffic.

In closing this road, Majara St, all traffic accessing Bungendore Primary school will be forced to merge on Malbon Street or most likely Gibraltar Street. Traffic congestion in this part of Gibraltar Street is already an issue for not only school drop off/pick up but for the customers of the Post Office and the users of both the School of Arts and the park.

We are a viable heritage town that attracts new residents and tourists. Bungendore was named second in Australia on the ME's best regional town for first-home buyers list. Bungendore has particular characteristics that are in danger of being entirely eroded by quick fix solutions. QPRC should respect and appreciate the uniqueness of the heritage part of Bungendore, should endeavour to preserve as much if not all heritage of the village and use the surrounding greenfields for future developments.

#### Proposed Majara Street Road Closure

I support a new High School in the Bungendore area.

I am not against carefully planned, considered development but I object to the proposed, limited site for the new High School and the impact it will have on the identity of the Community and the consequent health, freedom and safety of our children and residents. There must be other accessible and more suitable sites that could have been considered for an expanding high school development. Bungendore Village, with its extensive new housing developments to the north and south, is a charming relic of our Colonial and Aboriginal history. However, it is in danger of losing forever much of its precious heritage, and with it, tourist appeal and dollars, and the essence of what makes people want to live here.

With rushed community consultation during COVID and with little apparent knowledge of the local area, especially the grid layout of the village, traffic density and flow, the presence of the heritage railway station and the Canberra to Sydney railway line (not included in the original "artist's impression"), flood prone areas and recreational areas and use, the NSW Government (SI) presented the community with plans for an "Educational Precinct" to be built around the current Primary School, a school already at capacity, and removed from new housing developments. The community was offered a flawed questionnaire to survey "community support", and an Information Hub to sell the project. Both were an insult.

I find it difficult to believe that the closure of Majara Rd, running off Mc Clusker/Turallo St, is to be closed in order to create some of the space needed for a high school, and that the Mick Sherd Oval, the home of the Mudchooks since 1907, built by the community and maintained by generations of locals for many years is to be compromised, and the community built swimming pool and facilities, again built by the community, is to be bulldozed to add more space for the project. The Abbeyfield site is to be relocated between the Scout Hall and Pre school requiring a new DA, where there is a huge outlet drain onto the flood prone Common/off leash dog area! The oval, reduced in size, is to be a shared community/school facility. What happens when a fence goes around the high school perimeter as it will to provide security for children? Who takes over the responsibility for maintenance of the oval area?

Majara St is the non residential thoroughfare that directly links Elmslea (across the ford) to the heritage railway station, and the Kings Highway to the Coast. On Fridays, Saturdays and Sundays, in particular, it is very busy with 4WD vehicles, trailers, boats and caravans. This route, however, helps to keeps traffic flow away from residential areas. Traffic flow from Turallo St and Butmaroo St to Gibraltar St, both residential streets bordering the oval, will be increased by the closure of Majara St. Butmaroo St is truly a shared pedestrian thoroughfare that links pathways from Elmslea and the Ponds recreational park area, across Turallo St to the Mick Sherd Oval, tennis courts, Primary school, PO, Village coffee shops and the IGA. Any day of the week, at any hour of the day there is pedestrian traffic; walkers, walkers with dogs, joggers, and children and adults on bicycles and scooters. Despite no curbing or gutters, and no street lights, children feel safe and are confident to ride on paths across from the Ponds and continue on Butmaroo St across Gibraltar. With the building of a high school, Butmaroo St will become the school bus set down and pick up area for all students, and the vehicle route from Elmslea to the primary school drop off area in Gibraltar St, and beyond. It will also become the 4 WD speed way, across the dangerous intersection with Gibraltar St, to the Kings Highway. When the current condition of Butmaroo Road was questioned with respect to the anticipated increased volume of traffic, we were told it was local Council and not a State government responsibility!

We are not an inner city suburb of Sydney where land is scarce and prices are astronomical, but a small but expanding rural residential community with a precious, central heritage area that is a magnet for sporting and outdoor activities, and tourism. We are a walking and cycling community with a fit, active population of all ages. Children have space to grow, to become independent and explore the outdoors. The Council has to be applauded for maintaining the excellent facilities and open green spaces that are available for all of us to enjoy, now.

Please do not let this ill conceived, short sighted, expedient proposal from the NSW Government come to fruition. It will be our immediate loss, and deprive future generations of a chance to live and grow in a beautiful, healthy environment. I understand the financial constraints placed on the QPRC with the amalgamation of our two councils but surely we can take a long term outlook rather than a short term, knee jerk response. We are better than that.



I am writing to object to locating the high school on Bungendore's historic twin square and to the permanent closure of Majara Street in Bungendore. The park has been the town's central recreation space for over a century. Constructing a school on this site would represent the destruction of a significant heritage landscape that is currently much valued and used by residents.

Closure of Majara Street would represent a major reduction in accessibility for people living in Elmslea to other parts of the town and a backward step in better town integration. At present Majara street carries a heavy traffic flow-past that does not disturb several public buildings. I protest at the current initiative to close Majara Street.

Closing Majara St would tend to divert traffic to Turallo Tce's T junction of heavy traffic and poor visibility. Alternatively, it would increase the traffic down busy Gibraltar St, to the round-about and into Tarago Rd. It is surely better to disperse traffic out of town after school, than to move it unnecessarily, into busier areas.

Does NSW Education Dept. know there is no all-weather crossing between the village and Elmslea and Buckingham? If a safe road were to replace the low level crossing approximate to the Bungendore rail bridge, that northern end of Majara street would be a key access way.

I think a better move for Bungendore is to use the current Council building, in conjunction with Abbeyfield beside it, for community housing. It has the advantage of being close to town amenities: something much more important to that population than to the high school age group.

For years Bungendore students have gone to the ACT for secondary education. We now have an opportunity to select a north-facing campus; build on the foundations of our Maurice Barnes, Burt Reid, Ric Butt, to an environmentally sustainable and stimulating high school. Just as Canberra schools provided special options, Bungendore High School could address environmental industries or First Nation studies, or some aspects of changing agriculture... There could be campus accommodation available for outback (or similarly remote) students.

Bungendore needs a high school, but it doesn't need to be over the road from the post office and obliterating what many locals hold dear. Let us move forward to adjust to our newer residents, but the rural village has advantages that attract many. Let us hold onto those precious attractions.

#### **Closure of Majara Street**

Closure of Majara Street is another step in making more space available for the proposed high school, with a significant impact on the recreational facilities and the historic nature of the town. It is therefore appropriate to extend comments regarding the closure of Majara Street to include some other aspects of the impact of imposing the high school at the selected site.

To begin with, nobody I know resists the construction of a high school for Bungendore. What there is very strong feeling about is the proposed location with its consequential destructive effect on those attributes that have made Bungendore the special place to live in, and the disregard for the efforts of community groups that give a sense of pride and ownership; for example, the swimming pool that took the local community many years of fundraising (some say 15 or more). This is to be wiped away without a moment's thought.

Lack of consultation during COVID with little apparent knowledge of the local area, the local grid layout, traffic density and flood patterns has been viewed as an insult to people who would be most affected by the proposed changed. An on-line survey conducted by the Department of Education (DOE) late 2020 was indeed an insult to concerned individuals. After being asked if we support the proposal to provide a high school for Bungendore, <u>no significant opinion was sought</u>. The DOE Information Hub that visited Bungendore later in the year was even more of an insult to local people. Those representatives did not know that there was a railway line passing just behind the QPRC office building within the schools exclusion zone as laid down by DOE itself, or that McClusker Street, the main access road from Elmslea, would be flooded during periods of significant rain. This provides condemnation for the DOE planning process.

Emphasis has been put on the value of co-location the primary and secondary schools to justify the location of the high school– the so-called precinct. This opinion has been challenged by others who believe that a child's development is better enhanced by being removed from the same environment in which he/she has attended primary school for a protracted period with the same group moved to a broader environment where new friendships are formed and opinions are developed.

Notwithstanding the assumed need for co-location, the existing primary school is grossly overpopulated. In addition, population growth statistics suggest that even the new high school will need to be expanded within the easily foreseen future, with the continuing expansion of the Joint Operations Centre (JOC) and extensive new housing developments to the north and south of Bungendore now in progress. To accommodate this expansion would involve further damage to the historic Bungendore environment and further encroachment onto the Mick Sherd oval. If co-location is considered to be so important, construction of a new combined facility with room for future expansion at a suitable and less controversial location would be far more sensible than the current proposal. A long-term view that provides for co-location and further growth would be by far the most economical option and resolve many of the current short-term problems. A possible option could be colocation near the sports hub, so that the young adults could have access to decent sports facilities,

Little attention has been paid to the heritage value of the central part of Bungendore. Bungendore has been able to maintain much of its history with many buildings of heritage value. For example, the Cobb and Co. stables date to 1847, the oldest functioning post office in the country dates to 1892, and there are many other examples of mid-19<sup>th</sup> century town planning and architecture.

Document Set ID: 1112381 Version: 1, Version Date: 15/02/2021 The NSW Office of Environment and Heritage notes: "Bungendore's collection of 19th Century architecture and Town Planning makes it distinctive, if not unique" .....particularly "...the Bungendore Railway Precinct:" The Bungendore Structure Plan 2048 requires (on page 48)"...that the Council applies controls which conserve the character of any infill development which occurs within the original village area." The imposition of the school in this significant heritage area undermines the important examples of 19<sup>th</sup> Century planning and architecture. Closure of streets and construction of multi-story buildings would be utterly destructive to this historic atmosphere. The village would be less attractive to tourists and itinerant travellers, which would be detrimental to the hopes of businesses and hotels.

Examination of Bungendore development plans as recent as 2018 do not show any plan to develop a high school in this part of the town.

Bungendore park itself, which is largely to be incorporated into the high school facilities, is the oldest dedicated recreational facility in the town and an important part of Bungendore's heritage. Suggestions that the grounds can be shared between school users and sporting teams have been discounted by several authoritative sports people on the basis that the playing surface is a 'living thing', and it will not have time to recover between the various usages. As it is, Bungendore Park is an important facility for light usage, kite flying, use of the outdoor gym and children playing. Under these conditions it is able to withstand the usage of organised sport, but would not be able also to accommodate its use as a high school playground.

Despite the claim that the high school playing fields will not be fenced from the remainder of the sports oval, few government schools remain unfenced, and it appears unlikely that this school, to be newly built, would remain so,

Closure of Majara Street to provide space for the high school will cause prevent access from McClusker Street and Turallo Terrace

Majara Street links Turallo Terrace and McClusker Street to the Kings Highway. It provides access for workers traffic to the industrial areas during the week, and is a major access for 4WDs holiday vehicles, caravans and boats on the weekends. This is a very important access road through a nonresidential area that keeps traffic away from Butmaroo and Ellendon Streets, which are residential. Butmaroo provides access to the tennis courts, post office, shopping centres, primary school and other facilities. It is used by pedestrians, families walking dogs, cyclists and families with very small children on bicycles, particularly on the weekends when heavy traffic ie be boats, 4WDs, and caravans,would be using it. There is no kerbing or guttering.. Closing Majara Street will result in diverting much heavier traffic through Butmaroo particular, causing pedestrians and families who might otherwise walk to drive between Elmslea and Bungendore facilities along Butmaroo Streets or onto Tarago Road when the low level bridge in McClusker Street is flooded, further complicating traffic issues.

There need for a high school is recognised, but it is obvious that there has been no proper consideration of the overall impact of locating it where it is proposed. The planning process has been entirely flawed: there has been no traffic study; there has been no consideration of the impact of proposed location on the historic nature of the town; and there has been no study of the impact of the proposed closure of Majara Street.

Please do not allow this ill-conceived plan to be imposed on the Bungendore community.

Apologies for the delay of this submission however I did not realise until I submitted feedback for the proposed road closure Majara Street Bungendore that there was a component of the Amendment to Operational Plan 2020-21 - Property Addendum that proposed to lease part of the closed Majara St road reserve to Abbeyfield Housing under licence.

This is a terrible idea and I strongly object to locating an aged facility between a preschool and the scout hall when the land should be used to expand the preschool. Currently there is already traffic chaos creating a very dangerous situation at pick up and drop off and this will only be considerably worse with an aged care facility occupying the land where many parents park. I am truly amazed that there has not been a serious accident in recent years and is simply a reflection of how considerate and safety conscious Bungendore parents can be.

It also makes no sense from the perspective of creating an education precinct in the most logical place in Bungendore. The preschool has over 200 children on the waitlist who whilst eligible for preschool care are denied a place each year. This location would much better serve the community as a new or expansion to the preschool and should have an underground or lower-level parking facility with a significant, multi storey enquiry and play based early learning education centre under the capable management of the preschool. The management and educators are of an unparalleled level of dedication and caring for the children who are lucky enough to be offered a place, and it is horrific that we ask these same people to deny hundreds of children care each year. This facility should cater for all children prior to Kindergarten and address the complete lack of appropriate childcare facilities for Bungendore and the surrounding area.

Abbeyfield would be better located adjacent to the large self-contained retirement facility on Forster Street in what should be the retirement precinct. The proximity to the ambulance station and the logical step from self-contained to full retirement care makes perfect sense. Additionally the so called "residents group" who do not represent the majority of Bungendore residents, are primarily retirees, and are the primary objectors to the High School location and education precinct. I can't imagine that those same residents would want to spend their twilight years located somewhere where they have to look straight onto the education precinct, whilst being irritated at the noise, traffic and as they would say "destruction of the town" they have fought so hard against.

# Closing part of Majara Street will have a detrimental effect on the whole central section of our town.

Partially closing a road that is integral to the amenity of the centre of our town is very short sighted and can not be a long term solution for future developments. A full traffic study and a heritage assessment of this precinct should precede any decision to close this road.

The grid pattern that was adopted for the heritage part of Bungendore is simple and structured to enable ease of navigation by residents and visitors. Majara Street, between Turallo Terrace and Malbon Street, is a main thoroughfare for residents of Elmslea to access all the amenities of the town and by closing this road all traffic will be diverted down Turallo Terrace past the Preschool and then onto either Butmaroo or Ellendon Streets which are predominately residential. The traffic from the proposed developments to the north of Elmslea will also feed into McCusker Drive which will then add further volume to the current traffic.

#### Re: Majara Street Road Closure

I wish to register my objection to the proposed closure of Majara Street between Gibraltar Street and Turallo Terrace. The grounds for my objection are as follows:

- Majara Street is one of the main thorough fares between South Bungendore and the part of the town that is North of Turallo Creek. Its closure will force more traffic to use Ellendon Street where its intersection with Malbon Street is already a bottle neck. I cannot understand why Council will not put in a roundabout there.
- It will divert more traffic to Turallo Terrace which at present is a quiet residential street.
- More internal Bungendore traffic will be forced to use the old King's Highway, now called Tarago Road. Is it desirable to channel internal traffic onto a major through road?

The road closure is due to the decision to site the new high school on the Mick Sherd Oval, which is apparently a done deal with the state government. This decision was done without any consultation with the residents of the town. I have yet to find a resident who is in favour of that site and some question the need for Bungendore to have a high school now.

Council intends to sell the road reserve but has not said how it intends to use the proceeds. Here is a suggestion. Buy enough land from NSW Railways to move Majara Street closer to the railway line and continue it behind the existing Council Chambers. This would preserve it as a thoroughfare from South to North and would divert through traffic away from the Public School drop off zone. If Majara Street were extended to Trucking Yards Lane and the section between King and Hopkins Street sealed, it would take a lot of traffic away from Ellendon Street.



say that I am not in favour of the Majara Street road closure because of the following reasons:-

1. The impact that increased traffic would have on the heritage precinct of Bungendore, particularly Butmaroo Street which has many heritage buildings. These buildings were mentioned as significant in the 2018 Heritage Study done by Philip Leeson Architects, which updated the heritage study undertaken by David Scobie 36 years earlier. In the Philip Leeson study the buildings of significance in Butmaroo Street are Numbers 7, 9, 25, 35, 48 (Church) 52, 54, and 65.

In this study it states that 'the guidelines for development relating to heritage places shall be included in the new Bungendore DCP and shall be in accordance with the articles of the Burra Charter which aim to minimise the impact of development on the heritage significance of a place. It states that proposed developments are to limit **any** detrimental impact on the significance of an adjacent heritage place and I believe the increased traffic flow will have an adverse impact, particularly if the streetscape is not taken into account. I understand that a Traffic Management Strategy that identifies how movement to, from and around, the new school will work has been undertaken, and I think this study should be available to anyone who is concerned about the impact of increased traffic in the Heritage precinct. Has the study which included traffic counts, been completed in relation to traffic calming measures for Butmaroo Street? If so, this study should also be made available to the people of Bungendore prior to a decision being made on the closure of Majara Street.

2. In my opinion further investigation into the location of the Aboriginal burial ground should also be done. 20,000

Aboriginal artefacts were unearthed at the Defence Headquarters complex (HQ JOC) at Bungendore in 2007. The consulting archaeologist Doug Williams said, 'There's just a fascinating array of heritage material in this valley once you actually start to look. Although I suspect that its fairly characteristic of these sorts of landscapes in the local area, and the next valley across will be an archaeological gold mine for someone else.'Roads within the above facility were redirected subsequently, to retain the heritage values. My grandson found an Aboriginal axe head in our front garden in recently, so I have no doubt the area is very

rich in Aboriginal Heritage material which I assume, should also be respected in accordance with the Burra Charter.

I provide the following comments on the proposed road closure of Majara Street, Bungendore. The comments are provided separately on the two parcels of road:

- (A) the section of Majara Street roadway bounded by Turallo Terrace and Gibraltar Street, an area of approximately 6,025 sqm; and
- (B) the road reserve north of Turallo Terrace to the river corridor.

(A). <u>Traffic</u>: Closure of the section of road between Turallo Terrace and Gibralter Street would cause significant increase in traffic volumes along Turallo Terrace as a result of diverting traffic from Elmslea that previously used Majara st to access the Kings Highway; and similary traffic returning to Elmslea from the Bungendore shopping precinct. Feeder streets from Turallo Terrace to the shopping precinct or Kings Highway (Butmaroos Street, Ellenden Street) would face increased traffic volume, with both being residential streets (as opposed to Majara Street's primarily non-residential nature).

Although the council apparently has completed a <u>transport</u> study as part of the high school investigations, this study has not been released to the community. Similarly, according to recent media reports, a traffic study has been completed, but has not been made available to the community so that informed debate can occur about the impacts of the Majara St closure. Conveniently, this traffic study will be made available to the community after the closure of the public comment period on the road closure. I live on **traffic travel** along McCusker Driver and down Turallo terrace or Majara St. With the future development of North Elmslea, this traffic will increase significantly as the Council approved a Four-way intersection at McCusker Drive/Larmer street, which provides no disincentive for traffic leaving North Elmslea to continue down McCusker Drive and then Turallo Terrace. A much more sensible traffic option for North Elmslea would have been to force traffic to exit onto Tarago Road. This increasing traffic volume is not compatible with the residential nature of Turallo terrace.

Increased traffic along Turallo Terrace will increase the existing safety problems at the Turallo Terrace/Molonglo street intersection, which is already difficult to negotiate because of poor sight lines from Turallo Terrace along Tarago road to the north (as a result of the Bridge over Turallo Ck). There is a significant volume of sand trucks travelling southbound on Tarago Rd, often at or above the 50 Km/h speed limit, and entering this intersection is currently risky, and this will only get worse with additional vehicle movements from North Elmslea along McCusker drive/Turallo Terrace. This Turallo Terrace/Molonglo St/Tarago Rd intersection is a disaster waiting to happen.

<u>Pedestrian impacts</u>: Turallo Terrace has a high number of existing community facilities situated on it (pre-school, Swimming pool, scout/community hall, dog walking area, tennis courts, oval, churches, Bowling club) with considerable usage by elderly or juvenile residents. The pedestrian crossing between the Common and Butmaroo st also receives high usage by pedestrians, young cyclists, etc. The proposal to put the Abbeyfield development on Turallo Terrace as well, will simply increase the number of vulnerable pedestrians on this road, and the closure of Majara St and consequent diversion of traffic will increase the likelihood of a pedestrian/vehicle incident. This is without locating a high school on Turallo Terrace, and the associated kiss and drop traffic, and young, inexperienced student drivers also using the road. The proposal to locate the school/community hall off Turallo terrace, will also increase traffic on this street.

<u>Parking</u>: If Majara St is closed, the inability to access the existing parking on Majara Street adjacent to the Council chambers/Oval/swimming pool will displace those seeking parking to surrounding streets or nature strips. Such parking is already in high demand for the Pre School on Turallo Terrace, and the removal of the new car park between the scout/community Hall and the preschool will displace this existing parking demand to verges/nature strips in front of residential property on

Turallo Terrace, or result in unsafe parking on the road edge. Below is a February 2021 photo of parking at the preschool (only 1 side of Turallo terrace is shown but there were as many cars on the opposite side) with 12-15 cars often present. Also below is the parking demand when the Scout/community hall is in use (again, utilising both sides of the road).







Community Hall parking February 2021 ( a Local Land Services event)

With the proposed development/location of a school/Community Hall on Turallo Terrace, there will be additional parking demand. If it was just a school hall, this may be manageable as parking would have been largely limited to school days (Monday-Friday) and school hours. However, the community usage of this hall could be at all hours and all days, which again is not compatible with the residential nature of Turallo terrace.

(B). the closure of the road reserve between Turallo Terrace and the creek and the construction of Abbeyfield will not only remove the existing parking mentioned above, but will impose additional parking demand from Abbeyfield residents, staff and visitors. How and where will this parking demand be met?

The conversion of the remaining road reserve in this section to 'operational' land means exactly what? It is currently used as part of the off-leash dog area and I would have thought should remain as such. The failure to clarify the Councils intended use of the operational land is disturbing, given the continuing erosion of green space associated with the high school development.

#### Solutions:

The most sensible solution is to not close Majara St, and this was actually proposed as part of the high school development (following initial feedback to the high school development, and the revised roading solution outlined by Dept of Education staff at the Hub consultation period), but the revised road proposal was then abandoned again following the Hub consultation (with no reasons given).

If the current seeking of public comment on the closure of Majara St is real, then traffic and parking options need to be fully considered (after the almost mythical traffic and transport studies have been made available to the public. But assuming the council is pursuing its usual handballing *modus operandi* associated with the high school (out of our hands, we don't like it either but we risk getting no high school if we object, it's all the Department of Education's responsibility) then I assume that the decision has already been made to close Majara St and this public comment on the road closure is largely legislatively-required window-dressing. So if Majara Street is closed, then how can the traffic, pedestrian safety, and dangerous intersection issues be ameliorated? I suggest that a significant mitigation would be to close McCusker Drive to through traffic (so close it at the junction with McMahon Drive), which would then significantly reduce traffic volumes flowing to Turallo Terrace. McCusker Drive is already subject to seasonal closures as a result of the low-level causeway over Turallo Creek, and it would be a simple solution to divert southbound traffic onto Ashby Drive and then down Tarago Road. It would be better and less painful to do this now, rather than wait for the certain impacts that will be exacerbated when North Elmslea comes on-line.

Failing a closure of McCusker Drive, at the very least, substantial traffic calming measures must be deployed on McCusker Drive/Turallo terrace including speed humps, chicanes, reduced speed limits (max 40 kmh), however such measures would require some level of enforcement (speed camera?, police presence?).

The parking issue is much more problematic (pre school, Abbeyfield, Scout/Community Hall, School/Community Hall) and I don't believe there is currently viable alternatives to the existing. The land to the east of the Scout/Community Hall would be an option, but the High School Agricuture building has claimed this site. I think that the replacement of the parking that is going to be lost (Majara st, proposed Abbeyfield site) is far more important that an Ag. facility, given that the NSW Dept of Education has announced that Agriculture will be dropped from the NSW Curriculum in the next year or two.

Happy to elaborate further or enter into meaningful discussion. The unseemly rush to choose a substandard high school site to meet some political deadline is manifesting itself in really poor outcomes for the community. A more considered approach could result in a win all round which is supported by the entire community (rather than dividing it).

Council's Notice of Proposal to Close Part Majara Street, Bungendore

On 3 and 17 February 2021 Council published in the "Regional Independent" a newspaper circulating in Bungendore the following: "Proposed Road Closure Under Section 38B Roads Act 1993". The notice states "Under the provisions of the Roads Act 1993 notice is hereby given that Queanbeyan- Palerang Regional Council proposes to close the Council public road listed below---". The Notice advises that comments close at "5pm, Wednesday 3 March 2021" and concludes "For the Chief Executive Officer, Queanbeyan-Palerang Regional Council".

This is to advise that I consider Council, whether by Council itself or by its Chief Executive Officer on its behalf, has no legal authority to proceed as proposed.

The grounds on which to propose closure of a Council public road pursuant to s38B are provided by Sections 38A Roads Act. The Notice states that: "Council intends to sell the Majara Street road reserve as part of the new Bungendore High School project" as ground for proposing the closure of nominated parts of Majara Street. This does not fall within the closure grounds stated in s38A and indicates Council's intention to act beyond the authority permitted by the Act.

Further, Council's decisions of 6 July 2020 and 26 August 2020 in respect of the proposal by the Department of Education for the provision of a high school in Bungendore do not include a proposal for Council's public road closure.

Were Council to proceed on the basis given in the Notice it would be open to action by members of the community to seek remedial action by law. While Council may regard the proposal for a high school in Bungendore as providing community and financial benefit not presently available, the Roads Act 1993 does not provide support for Council's public road closure proposal in pursuit of such benefits.

Bungendore High School Action Group (BHSAG) is an apolitical group of parents and grandparents, who sole aim was to have a public high school for our community by 2022. Over many years, various groups before us have also lobbied for a local high school – some individuals are now grandparents, who hope that their grandchildren will complete their secondary education in Bungendore. In late 2018, due to the overwhelming support of the community, bi-partisan commitment was made for a Bungendore High School to be built and open for the first intake of students in 2023.

Attached for your information is a document we prepared in 2018 to support the case for a high school in Bungendore. It also includes comments from families within our community about what a high school would mean for them. As pointed out in the document:

- Our population is now large enough to support a high school;
- Having no local high school impacts on families and our community;
- Preferred high school choices are no longer available;
- The available options disperse the local high school cohort, are impractical or will have capacity issues;
- The wider community supports and wants a school; and
- Our children and community would significantly benefit from a local high school.

Many families are or have been making life changing decisions to stay or come to Bungendore, influenced by the commitment of a local high school by 2023. There are over 1,000 students in the local primary schools in our region. Each year that a high school is delayed an additional 100 to 150 children and their families in the Bungendore area are affected. Traditionally most local students went to high school in central Canberra. Since 2018, the ACT Government effectively closed access for NSW students to these high schools and the most popular ACT non-government schools for our local families also started to severely restrict access. With the high school options considerably decreased, more families from Bungendore and the surrounding areas are now considering leaving. For many of them, we believe more than ever, that a local high school is a critical issue.

BSHAG supports the proposed partial closure of Majara Street as an essential part of the work to establish the high school by 2023. We are supportive of the proposed location. We believe that the majority of the community support this location and the significant investment back into our community facilities that it brings to Bungendore. Families see the central location as a safe option for their children or grandchildren, and many more in the community view this proposal as an excellent use of existing infrastructure and welcome the new community pool, library and community centre as well as the upgrades to the primary school.

We appreciate that there would be concerns for those who live beside whatever site was chosen and for those that do not want to see any further change to the town. While there has been a concerted campaign on Facebook opposing the proposed location of the high school, we believe that this is not representative of the majority of the community. Most people either do not like to debate on social media or unfortunately are afraid to comment publicly for fear of being at the receiving end of intimidating, disrespectful or unkind behaviour.

The Department of Education has indicated that the Government has made its decision on this site and no other sites are being considered. To delay or refuse a decision on closure of Majara Street could delay the construction of the high school or, if there is significant pressure on the NSW Budget from competing claims, could even result in diversion of funds allocated to the Bungendore High School to schools in other areas, e.g. Sydney.

The commitment to build a high school was a bi-partisan one and no matter who was in Government, we would be looking at this site. The proposed infrastructural investment for a town the size of Bungendore is unprecedented, and we ask you to support this high school proposal.

We are continuing to see a lot of misinformation. We urge Council to continue to communicate about updates to the project and the associated community facilities, including any planned transitional arrangements for users of the facilities affected.

### The issue

1. There is no local high school but our population is large enough to support one

Bungendore is part of the fastest growing area in regional NSW<sup>i</sup> and has seen significant growth in recent years. There are now over 12,000 residents including 3,300 children living in the wider region.<sup>ii</sup> Since 2011 the number of primary aged children in Bungendore has grown by 28 per cent. As as 2018, there are 1,000 students in the local primary schools in Bungendore, Sutton, Tarago, Captains Flat and Gundaroo.<sup>iii</sup> These students will all need to go to high school.

### 2. The preferred high school choices are no longer available

In the past, most local children went to high school in central Canberra – frequently travelling with parents to reduce commute times or enable extracurricular activities. In a 2015 survey, three out of four parents were either sending or intending to send their children to a high school in Canberra, with Campbell High the preferred option. Less than 15 per cent indicated the three nearest NSW schools.<sup>iv</sup> However, as of 2018, the ACT Government no longer accepts NSW students into high schools in central Canberra (i.e. Campbell High and Dickson College from Year 11).<sup>v</sup> Some popular ACT non-government schools have also said they can no longer guarantee places for NSW students in 2019.

# 3. The available options disperse the local high school cohort, are impractical or will soon have capacity issues

The available public-school options are impractical for many families due to commute times or lack of direct bus services. With Campbell High no longer available, the local high school cohort is now dispersed in small numbers across many schools.

Except for Tarago, our local primary schools officially feed into Queanbeyan High School. The nearest NSW public high schools (Queanbeyan and Karabar) also service a large proportion of the expanding NSW communities on the ACT border. If these schools were to accept all students seeking a public high school from nearby primary schools as well as the Bungendore region, they would need an estimated additional 1000 places by 2022 (four times current available capacity).<sup>vi</sup> Braidwood Central is nearly 90km in the opposite direction from Canberra, where most parents work – this makes extracurricular activities and appointments difficult.

Bungendore High School ACTION GROUP

The available ACT pathway schools for the Bungendore region are South Canberra (Tuggeranong) or North West Canberra (Belconnen) depending on where you live.<sup>vii</sup> However, these options do not have direct bus services and involve lengthy travel times. With the high school options considerably decreased, more families are considering leaving.

### The solution

Build a public high school in Bungendore by 2022.

### Why Government should support a public high school in Bungendore

#### 4. A local high school would greatly benefit our local teenagers and families

Every day over 20 buses take our teenagers to schools outside the Bungendore region. To get to the nearest high schools by direct bus, Bungendore children leave home at 7.30am in the morning. For many outside Bungendore, their commute starts much earlier. Concerns have also been expressed about children travelling on buses without seatbelts, on busy roads, and sometimes in crowded conditions. When children reach high school age, many families leave the area<sup>viii</sup> to avoid long and potentially unsafe commutes for their children. Having no high school impacts on our community, including added family stress and the loss of close friends.

The benefits of a local high school for students are considerable, including the ability to maintain friendships made in primary school, an extra ten hours plus per week for local sport, community or cultural activities, part-time work, study and family life – ultimately leading to better academic and social outcomes.

#### 5. A high school in Bungendore would strengthen the regional community

In a 2015 survey, 97 per cent of community respondents supported a high school in Bungendore.<sup>ix</sup> Three out of four parents said a high school would influence their decision to stay in the area, with 80 per cent favouring a public high school.<sup>x</sup> The P&Cs at the local schools and families from the surrounding communities of Bywong, Wamboin, Hoskinstown, Sutton, Tarago, Lake Bathurst, Captains Flat, Gundaroo and all the rural residential properties in between have shown strong support for a high school in Bungendore.

A high school would bring economic benefits to Bungendore, including creating income and jobs locally, both during construction and operation. It would also enable opportunities for our teenagers to feel more connected to the community, such as participating in volunteering, part-time work or senior levels of sport ultimately boosting Bungendore as a place to live and raise children.

#### 6. The issue is only going to become more critical

Independent of any further development, the population for Bungendore is projected to grow to over 5,000 (by 17 per cent) by 2036, with almost 11,000 in the surrounding community.<sup>xi</sup> By 2022, there will be almost 1,100 children of high school age in the proposed catchment area.<sup>xii</sup>

Based on the population at the time of the last census, and the average percentage of students in Australia that attend public high schools, there would be 100 students available to start year seven in 2022.<sup>xiii</sup>

The lower housing cost in rural areas outside Canberra attracts young families and Bungendore, Wamboin, Bywong, Sutton, Tarago, Captains Flat and Gundaroo are all growing communities. A few large additional developments are proposed. So, the above figures are conservative.

### **Key considerations**

### 7. Community consultation is necessary to ensure the high school is the best fit

Bungendore Public School is already near capacity<sup>xiv</sup>. It is important that any high school option enhances rather than strains current resources at the primary school. A standalone high school is necessary to allow expansion of the primary school. If large scale proposed developments proceed, we will see significant population growth in the area and subsequent pressure on the primary school.<sup>xv</sup>

Some of the best public schools engage a large proportion of their local community. The Bungendore region has a very engaged, creative and educated community. It's vital that a local high school builds on this engagement by not only providing a multifunctional school but also by consulting the community on what type of school is the best fit for most.

#### 8. A collaborative educational approach could broaden the wider NSW offering

Local rural schools play a vital role in their communities. We believe there is an opportunity to enhance and broaden the educational offering across schools in the wider region by sharing specialist teaching resources. For example, a specialist technology teacher (e.g. a coder) could be based in Bungendore but travel to Braidwood, and potentially Queanbeyan and Yass. Likewise, Bungendore region students with an interest in agricultural science or performing arts could potentially access programs through Braidwood or Karabar.

The wider Bungendore community has a population large enough to support a public high school. However, with the high school options considerably decreased, a local high school is a critical issue for many families deciding whether to stay in the area. It is important that there is a firm commitment soon to build a public high school in Bungendore – ready for students by 2022 – rather than leave the planning and decisions until they become even more critical.

### What local parents are saying

'Nine years ago, my husband and I made the decision to build in Bungendore. We were given glowing reports of the local primary school and told, that given the growth of Bungendore, there would need to be a high school built. Nine years on, I now have two children and it is of grave concern to me that there are still no firm plans for one. A high school would mean the difference between staying in a community we love or moving back to Canberra.'

'It's not just about Bungendore kids. Sutton Public is a beautiful little school with a wonderful community atmosphere. The children grow up exceptionally close, but once they hit Year 7 they're scattered to the wind. For many of us living around the Federal Highway, getting to Queanbeyan for high school is much more hassle and time consuming than getting to Gungahlin. A 10 minute direct high school bus straight down Macs Reef Road and the other key feeder roads to Bungendore would

be a godsend for our kids. **A Bungendore high school would keep our community together**. All four of the ACT high schools on offer to our kids are just not suitable for those of us in the Federal Highway precinct.'

'We have a five-year-old child who will be facing a daily commute into Canberra, Queanbeyan or Braidwood when she reaches year seven, with our only other option being relocation. We have seen other families do this, while also seeing all the town's local teenagers who live in Bungendore doing the lengthy and exhausting commute. Bungendore's rapidly growing population, mostly made up of young families, warrants a high school, particularly considering the number of children attending local primary schools in the wider area. **A public high school in Bungendore is well overdue.'** (Ant Schulz, Bungendore)

'My son is currently attending Campbell High. He catches a bus to school at 6.40am (from our front gate) and doesn't return home until 5.00pm. For a 13-yearold, it's a very long day and it has taken its toll on him. He struggles to do his assignments and homework, they are always rushed. He is usually too tired to really put in the effort that's required, which has been expressed to us as a cause of concern by his teachers. We have had some serious discussions about whether we move back to Canberra, especially with the limited options we will have when our youngest goes to high school. We would be very relieved if the proposed Bungendore high school went ahead.'

'Would love to send our daughter to a high school in Bungendore if it's available.' (Sara Stidworthy, Gundaroo)

After school activities such as footy training or gymnastics and social facilities in Bungendore can be used by kids from the whole region instead of them spending an hour plus on the bus – **a high school would be a massive benefit for the town in general.** I am in Carwoola, just near Hoskinstown, so I am closer to Bungendore than Queanbeyan. I have two children that I hope will attend a Bungendore High School.' (Neil Willis, Carwoola)

'With our child at Sutton primary the possibility that she will be able to attend a local high school is very important for us. I have seen the high school students on my street for many years leaving home at 7:10 to catch the bus to their Canberra high school. In the afternoon they do not arrive back till approximately 4:30 (at the bus stop, not home). With the levels of homework and assessment required in the higher school years (I know as I have taught in high school and college in the ACT public education system) there is little time for much else after family commitments – for some that run farms that can be significant.'

There seemed to be a correlation that learning, whether it be literacy or numeracy of 'out of area' students, was lower or below the average of students who live in the immediate area!

We want the best education for our students/children and providing one closer to our community should take precedence over the need for anything else! The Department doesn't see the stresses, the anxiety and the expectations that schools place on students regardless of where they live! Teachers don't give extensions to students that live out of town! These students are disadvantaged. The need for a closer school is imperative if educational measures and performances are to improve!

For a community to function effectively we need our essential services for all children – this should be the right of any community. **Having a school in closer proximity would encourage our sense of community, sense of support for each other and allow our kids to enjoy balance in life.** For travel to take up so much time, these kids are not leading a balanced life – two more hours each day for learning life skills, or merely visiting a neighbour would improve outcomes both from a personal sense but also an educational one.'

'I want our kids to have the opportunity to continue their schooling and extracurricular activities ...with their friends, peers and family networks in Bungendore. For safety reasons and loss of quality time, our kids should not need to travel 2-4 hours every day on dangerous roads and via interchanges...

At present, from the age of 12-13, all our kids are segregated by religion, gender or ability to pay for private school fees (or all of the above) which can impact on the cohesiveness of our community. It can also affect the feasibility of healthy and constructive after-school activities for this age group, such as homework, scouts, orchestra, dance, athletics, swim club, walking the dog and helping on family farms

Kids are stuck on buses for hours and are then only able to start after-school activities from around 4:30-5pm. For some it means not being able to get involved in organised activities in Bungendore during the week. For these reasons, some families decide to move to Canberra when their kids start high school and their valuable contribution is lost to our local community. With over 500 kids at Bungendore primary school alone and with Canberra and Queanbeyan schools reaching capacity and turning kids away from our region, it is time for the NSW Government to provide a high school here in Bungendore' (Nicola Bryden, Founder, Bungendore Youth Orchestra)

'I no longer have school-aged kids, so I'm thinking about a high school from a broader, societal standpoint. Having a school that would offer high-quality education to local students without the need for extensive travel by bus or car would be an enormous social good, not just for kids and their parents but for the whole community. The knock-on effects would be employment for teachers and other staff, bringing them to our community, increasing our housing values and the cohesiveness of our community. Finally, a high school can often host athletic or

### What former residents are saying

'I would like to move back to Gundaroo in the next few years to start a family. The need for a high school in Bungendore is a long-term requirement that seems to be getting overlooked. With the anticipated development of Gundaroo, the village itself could see a dramatic population increase over the next couple of years. Further, with the expansion of both Murrumbateman and the Queanbeyan region, residents of not only Gundaroo, but Sutton and Bungendore could find themselves without a secondary school. With limited schooling available in the ACT, Murrumbateman students will fill any remaining places available at Yass High, before Gundaroo students will have the chance. Queanbeyan high schools will undoubtedly accept students from the immediate area before opening its doors to students from Gundaroo and surrounds. Therefore, a high school in Bungendore is essential for the sustainability of secondary education for our community.'

Between 2011 and 2016 the population of Bungendore grew by 18% with the number of primary school age children increasing by 28%. (This latter percentage was referenced through census data collated by profile id by service age group).

#### BUNGENDORE HIGH SCHOOL ACTION GROUP SUBMISSION ON PROPOSED PARTIAL CLOSURE OF MAJARA STREET BUNGENDORE

Bungendore High School Action Group (BHSAG) is an apolitical group of parents and grandparents, who sole aim was to have a public high school for our community by 2022. Over many years, various groups before us have also lobbied for a local high school – some individuals are now grandparents, who hope that their grandchildren will complete their secondary education in Bungendore. In late 2018, due to the overwhelming support of the community, bi-partisan commitment was made for a Bungendore High School to be built and open for the first intake of students in 2023.

Attached for your information is a document we prepared in 2018 to support the case for a high school in Bungendore. It also includes comments from families within our community about what a high school would mean for them. As pointed out in the document:

- Our population is now large enough to support a high school;
- Having no local high school impacts on families and our community;
- Preferred high school choices are no longer available;
- The available options disperse the local high school cohort, are impractical or will have capacity issues;
- The wider community supports and wants a school; and
- Our children and community would significantly benefit from a local high school.

Many families are or have been making life changing decisions to stay or come to Bungendore, influenced by the commitment of a local high school by 2023. There are over 1,000 students in the local primary schools in our region. Each year that a high school is delayed an additional 100 to 150 children and their families in the Bungendore area are affected. Traditionally most local students went to high school in central Canberra. Since 2018, the ACT Government effectively closed access for NSW students to these high schools and the most popular ACT non-government schools for our local families also started to severely restrict access. With the high school options considerably decreased, more families from Bungendore and the surrounding areas are now considering leaving. For many of them, we believe more than ever, that a local high school is a critical issue.

BSHAG supports the proposed partial closure of Majara Street as an essential part of the work to establish the high school by 2023. We are supportive of the proposed location. We believe that the majority of the community support this location and the significant investment back into our community facilities that it brings to Bungendore. Families see the central location as a safe option for their children or grandchildren, and many more in the community view this proposal as an excellent use of existing infrastructure and welcome the new community pool, library and community centre as well as the upgrades to the primary school.

We appreciate that there would be concerns for those who live beside whatever site was chosen and for those that do not want to see any further change to the town. While there has been a concerted campaign on Facebook opposing the proposed location of the high school, we believe that this is not representative of the majority of the community. Most people either do not like to debate on social media or unfortunately are afraid to comment publicly for fear of being at the receiving end of intimidating, disrespectful or unkind behaviour.

The Department of Education has indicated that the Government has made its decision on this site and no other sites are being considered. To delay or refuse a decision on closure of Majara Street could delay the construction of the high school or, if there is significant pressure on the NSW Budget from competing claims, could even result in diversion of funds allocated to the Bungendore High School to schools in other areas, e.g. Sydney.

The commitment to build a high school was a bi-partisan one and no matter who was in Government, we would be looking at this site. The proposed infrastructural investment for a town the size of Bungendore is unprecedented, and we ask you to support this high school proposal.

We are continuing to see a lot of misinformation. We urge Council to continue to communicate about updates to the project and the associated community facilities, including any planned transitional arrangements for users of the facilities affected.

### The issue

#### 1. There is no local high school but our population is large enough to support one

Bungendore is part of the fastest growing area in regional NSW<sup>i</sup> and has seen significant growth in recent years. There are now over 12,000 residents including 3,300 children living in the wider region.<sup>ii</sup> Since 2011 the number of primary aged children in Bungendore has grown by 28 per cent. As as 2018, there are 1,000 students in the local primary schools in Bungendore, Sutton, Tarago, Captains Flat and Gundaroo.<sup>iii</sup> These students will all need to go to high school.

### 2. The preferred high school choices are no longer available

In the past, most local children went to high school in central Canberra – frequently travelling with parents to reduce commute times or enable extracurricular activities. In a 2015 survey, three out of four parents were either sending or intending to send their children to a high school in Canberra, with Campbell High the preferred option. Less than 15 per cent indicated the three nearest NSW schools.<sup>iv</sup> However, as of 2018, the ACT Government no longer accepts NSW students into high schools in central Canberra (i.e. Campbell High and Dickson College from Year 11).<sup>v</sup> Some popular ACT non-government schools have also said they can no longer guarantee places for NSW students in 2019.

# 3. The available options disperse the local high school cohort, are impractical or will soon have capacity issues

The available public-school options are impractical for many families due to commute times or lack of direct bus services. With Campbell High no longer available, the local high school cohort is now dispersed in small numbers across many schools.

Except for Tarago, our local primary schools officially feed into Queanbeyan High School. The nearest NSW public high schools (Queanbeyan and Karabar) also service a large proportion of the expanding NSW communities on the ACT border. If these schools were to accept all students seeking a public high school from nearby primary schools as well as the Bungendore region, they would need an estimated additional 1000 places by 2022 (four times current available capacity).<sup>vi</sup> Braidwood Central is nearly 90km in the opposite direction from Canberra, where most parents work – this makes extracurricular activities and appointments difficult.

The available ACT pathway schools for the Bungendore region are South Canberra (Tuggeranong) or North West Canberra (Belconnen) depending on where you live.<sup>vii</sup> However, these options do not have direct bus services and involve lengthy travel times. With the high school options considerably decreased, more families are considering leaving.

### The solution

Build a public high school in Bungendore by 2022.

### Why Government should support a public high school in Bungendore

### 4. A local high school would greatly benefit our local teenagers and families

Every day over 20 buses take our teenagers to schools outside the Bungendore region. To get to the nearest high schools by direct bus, Bungendore children leave home at 7.30am in the morning. For many outside Bungendore, their commute starts much earlier. Concerns have also been expressed about children travelling on buses without seatbelts, on busy roads, and sometimes in crowded conditions. When children reach high school age, many families leave the area<sup>viii</sup> to avoid long and potentially unsafe commutes for their children. Having no high school impacts on our community, including added family stress and the loss of close friends.

The benefits of a local high school for students are considerable, including the ability to maintain friendships made in primary school, an extra ten hours plus per week for local sport, community or cultural activities, part-time work, study and family life – ultimately leading to better academic and social outcomes.

### 5. A high school in Bungendore would strengthen the regional community

In a 2015 survey, 97 per cent of community respondents supported a high school in Bungendore.<sup>ix</sup> Three out of four parents said a high school would influence their decision to stay in the area, with 80 per cent favouring a public high school.<sup>x</sup> The P&Cs at the local schools and families from the surrounding communities of Bywong, Wamboin, Hoskinstown, Sutton, Tarago, Lake Bathurst, Captains Flat, Gundaroo and all the rural residential properties in between have shown strong support for a high school in Bungendore.

A high school would bring economic benefits to Bungendore, including creating income and jobs locally, both during construction and operation. It would also enable opportunities for our teenagers to feel more connected to the community, such as participating in volunteering, part-time work or senior levels of sport ultimately boosting Bungendore as a place to live and raise children.

### 6. The issue is only going to become more critical

Independent of any further development, the population for Bungendore is projected to grow to over 5,000 (by 17 per cent) by 2036, with almost 11,000 in the surrounding community.<sup>xi</sup> By 2022, there will be almost 1,100 children of high school age in the proposed catchment area.<sup>xii</sup>

Based on the population at the time of the last census, and the average percentage of students in Australia that attend public high schools, there would be 100 students available to start year seven in 2022.<sup>xiii</sup>

The lower housing cost in rural areas outside Canberra attracts young families and Bungendore, Wamboin, Bywong, Sutton, Tarago, Captains Flat and Gundaroo are all growing communities. A few large additional developments are proposed. So, the above figures are conservative.

### **Key considerations**

### 7. Community consultation is necessary to ensure the high school is the best fit

Bungendore Public School is already near capacity<sup>xiv</sup>. It is important that any high school option enhances rather than strains current resources at the primary school. A standalone high school is necessary to allow expansion of the primary school. If large scale proposed developments proceed, we will see significant population growth in the area and subsequent pressure on the primary school.<sup>xv</sup>

Some of the best public schools engage a large proportion of their local community. The Bungendore region has a very engaged, creative and educated community. It's vital that a local high school builds on this engagement by not only providing a multifunctional school but also by consulting the community on what type of school is the best fit for most.

#### 8. A collaborative educational approach could broaden the wider NSW offering

Local rural schools play a vital role in their communities. We believe there is an opportunity to enhance and broaden the educational offering across schools in the wider region by sharing specialist teaching resources. For example, a specialist technology teacher (e.g. a coder) could be based in Bungendore but travel to Braidwood, and potentially Queanbeyan and Yass. Likewise, Bungendore region students with an interest in agricultural science or performing arts could potentially access programs through Braidwood or Karabar.

The wider Bungendore community has a population large enough to support a public high school. However, with the high school options considerably decreased, a local high school is a critical issue for many families deciding whether to stay in the area. It is important that there is a firm commitment soon to build a public high school in Bungendore – ready for students by 2022 – rather than leave the planning and decisions until they become even more critical.

At present, from the age of 12-13, all our kids are segregated by religion, gender or ability to pay for private school fees (or all of the above) which can impact on the cohesiveness of our community. It can also affect the feasibility of healthy and constructive after-school activities for this age group, such as homework, scouts, orchestra, dance, athletics, swim club, walking the dog and helping on family farms

Kids are stuck on buses for hours and are then only able to start after-school activities from around 4:30-5pm. For some it means not being able to get involved in organised activities in Bungendore during the week. For these reasons, some families decide to move to Canberra when their kids start high school and their valuable contribution is lost to our local community. With over 500 kids at Bungendore primary school alone and with Canberra and Queanbeyan schools reaching capacity and turning kids away from our region, it is time for the NSW Government to provide a high school here in Bungendore' (Nicola Bryden, Founder, Bungendore Youth Orchestra)

I wish to make comments regarding the above proposal the Council have on their 'drawing board' at present.

I would certainly **NOT** like to see any of Majara Street closed as it is a main thoroughfare through the township for many depending on where you live and what activities you are endeavouring to attend by traversing along Majara Street.

It will no doubt increase the traffic significantly along both Turallo Terrace, Butmaroo Street and Ellendon Street, obviously in the vicinity between Gibraltar St & Turallo Terrace.

The preschool has no formal carparking for dropping off and collection of children 'albeit the nature strip' (which has to date worked without any issues) and with the increased volume of traffic this will increase the danger to pedestrian & vehicle traffic in that immediate area.

I have made a short on-line comment supporting the proposed partial closure of Majara Street Bungendore but would like to add some additional comments as someone who uses Turallo Terrace daily and sometimes uses Majara Street.

Firstly, there have been claims on Facebook by a small vocal group of people regarding the possible adverse impacts of a high school in that location and also impacts of closing the road. Regarding the opponents to the location of the school, this is a small group as evidenced by the fact that the Bungendore Community Noticeboard Facebook page has some 5,200 members, but posts by this group only get about 20 responses each time.

Secondly, they have made claims that closing this small section of road will cause traffic chaos. We all know that a traffic study and plan is required and we understand Council will work with the Department of Education to do this. However it is clear that many people (including me) currently use alternative parallel roads from Elmslea to go to south Bungendore or go to Queanbeyan because they are shorter (Butmaroo Street, Ellendon Street and Tarago Road). When the traffic to the Council chambers is removed and the pool is closed there will be a lot less traffic on Majara Street. Butmaroo Street is a wide street used by a lot of people already. I refer to the proposed closure of Majara Street, north of Gibraltar Street.

Majara Street is a major, non-residential thoroughfare in Bungendore. It is part of the town's original grid, laid out in 1837. It is an essential transport route through the town, connecting hundreds of homes in Elmslea with the Kings Highway and other important facilities. It carries significant traffic volume, including large utes and 4WDs – many of which tow boats or caravans on weekends or holiday periods. Further, traffic volume to and from Elmslea is likely to increase significantly as the proposed North Elmslea development proceeds.

- Closure between Gibraltar Street and Turallo Terrace

Closing Majara Street between Turallo Terrace and Gibraltar Street will divert all traffic currently using the road onto Turallo Terrace, and then primarily to Butmaroo and Ellendon Streets.

Bungendore Preschool is on Turallo Terrace. There are already significant traffic issues at pick-up and drop-off times, which will be exacerbated by the increase in passing traffic. In addition, increasing traffic flow around the preschool poses a much greater risk to children who may be arriving/departing or exploring their surrounds. The proposal to construct parking on Turallo Terrace will only increase the number of pedestrians (many with children) crossing back and forth across this road.

Butmaroo Street in particular attracts a large number cyclists, dog-walkers and other pedestrian traffic including young children, travelling to Bungendore Park, the Common, Elsmlea or the tennis courts. This street is basically a canine superhighway for dogs and their owners. Other than pedestrian traffic, it is a quiet and purely residential street. The road is unkerbed and there is no formal separation between the road and verge. It would raise significant safety concerns if traffic were diverted on to this street, as it must be if Majara Street is closed.

I understand that there is a proposal to construct a road behind the Palerang Council Building. These plans are not confirmed but it appears that if it proceeds, it would contain several dog-legs and be intended as a local access road only. It would not be suitable for through traffic and could not be a substitute for Majara Street and could not accommodate the high volume of through traffic on that street.

Possible mitigation strategies such as (for example) closing Butmaroo and/or Ellendon Streets to through traffic would only divert the problem further along Turallo Terrace and increase the likelihood of accidents at the intersection of Turallo Terrace and Tarago Road.

In short, there is no satisfactory way to manage the impact of closing Majara Street.

It was very surprising to hear the Council's CEO, Peter Tegart on ABC Radio last week admitting he had not read the traffic study on the impact of the road closure. Why did Council announce its intention to close the road when it did not have this information? How can the public consider the impact of this closure and make submissions, when this information has not been made available? Has Council considered the impact of the North Elmslea development when modelling the impact of closing Majara Street?

- Closure of the road reserve north of Turallo Terrace

The proposed closure includes the road reservation which extends north of Turallo Terrace and into Bungendore Common. This land would be reclassified as "operational land" under the Local Government Act, and be available for sale.

While the removal of the road reserve itself has minimal impact, it is inappropriate for the land to be classified as "operational". It should instead be classified as community land. It is a defacto part of Bungendore Common and the off-leash dog area and is heavily used by the public for sport and recreation.

Bungendore Common is heritage protected under the Local Environmental Plan on the basis of its historic cultural and social significance. The road reserve has always been considered part of the Common and is equally significant. If the road reserve is to be closed, it should not be classified as operational land and available for sale – instead it should be treated as community land and included as part of the Common – which for all practical purposes it already is.


- Conclusion

#### Dear Councillors,

I am concerned about the adverse impact on both vehicle and pedestrian traffic on Ellendon St once Majara Street is closed between Turallo Tce and Gibraltar Street.

Vehicles travelling from Elmslea (and the expanded Elmslea once the development in the north east is approved) into the township will have fewer options to access the roads to the Coast, to the Federal Highway and to Queanbeyan. As I see it the options are:

- Turn left or south on Butmaroo St (which is likely to be decreed a 40 KPH zone because it borders the new high school, or
- Turn left into Ellendon St, or
- Turn left onto Molonglo St and compete with traffic flowing from Elmslea and Buckingham and the rural residential/farming areas to the north coming over the Molonglo St bridge often well in excess of the speed limit.

I suspect that the main flow will be down Ellendon St.

My home is located at 12 Ellendon St and I observe both the foot and vehicle traffic moving in both directions along that street.


At the very least the road needs widening and a footpath is needed to cope with foot traffic.

I noted in Council's plan that Majura Road is to be extended through the current parking area between the Scout Hall and the Early Learning Centre across the flood plain to the Creek. Section B is a recreational area for many local inhabitants and their dogs and, if it is shut off totally, will inhibit community usage along the creek to adjoining green spaces downstream. As suggested in Council's handout to obtain "more information" I have tried to contact Council's Legal Team but have not received any responses to my telephonic requests which, I understand, have been forwarded to that area. I would still appreciate it if a person/planner who is knowledgeable on the closure of Section B of Majura Road could call me on either or so that I can make an appropriate comment on this proposal by Council.





#### Re: Majara Street Roadway, Bungendore (Ref: 2020:70:SN)

I refer to your letter dated 3 February 2021 on the above matter and thank you for the opportunity to make comment on the proposed road closure. Council is the owner of potable water, sewer, recycled water and stormwater assets in the Queanbeyan-Palerang Local Government Area. Responsibility for construction, operation and maintenance of these assets resides with the Utilities Branch of Council.

This letter represents comments from Council's Utilities Branch and does not reflect comments from the organisation in its entirety. Gas and telecommunications assets are not within the ownership of Council and therefore no comment is made on these assets. Comment on assets owned by other parties should be sought from those parties.

#### Impacted Assets

Council owns a number of assets within the proposed Majara Street closure extent. These assets are shown on the figure shown in Attachment A and comprise:

- One 150mm diameter DICL potable water main (blue line) and associated stop valves and hydrants generally within the area between Turallo Terrace and Gibraltar Street
- One 150mm diameter PVC sewer main (dark red lines) and associated sewer manholes starting approximately midway between Turallo Terrace and Gibraltar Street and extending to Turallo Terrace
- One 1400mm diameter RCP stormwater drain (green lines) and associated manholes, inlet structures and outlet structures running from Gibraltar Street to the approximate northern edge of the proposed Abbeyfield lot

Although not recognised as formal stormwater assets, the Utilities Branch wishes to draw your attention to the overland stormwater flow paths along Majara Street and from the outlet of the 1400mm stormwater pipe heading towards Turallo Creek.

#### Consultation to date with DoE

Utilities staff have been working with the NSW Department of Education (DoE) on the closure of Majara Street required to accommodate the proposed high school in Bungendore.

Utilities staff have stressed their concern about retaining assets within an enclosed environment such as a school. This concern is based on previous experience in dealing with issues related to the protection of children and emergency access, particularly with respect to sewer maintenance. As such, Utilities staff have proposed handing over the sewer main to DoE as their asset. If this were to occur, no sewer easement would be required.

Council staff have provided advice on required easements and potential servicing arrangements. Copies of this correspondence are attached in Attachment B and draft easement plans are shown in Attachment C.

#### Protection of network functionality, operation and maintenance

The Utilities Branch considers the protection of the listed assets to be critical for the effective management of the utilities networks and their on-going functionality. In order to effectively maintain these critical community assets, the following easement will be required where Council assets are within the road reserve to be closed:

- Stormwater
  - A 5.0m wide easement created centrally over the existing pipes
  - A 10.0m wide easement commencing 5.0m upstream of the outlet structure and extending along a line drawn from the centre of the outlet structure to the intersection with Turallo Creek and parallel to the existing road reserve boundary
- Sewer if not handed over to DoE as discussed above, a 2.5m wide easement created centrally over the existing pipes
- · Potable water A 2.5m wide easement created centrally over the existing pipes

The easements should benefit Council, only able to be amended by Council and permit the unfettered access to operate, maintain and upgrade/repair assets as necessary. The easement should also prevent the construction of any permanent structures over Council assets.

Where possible and particularly where proposed easements overlap, we are supportive of consolidating easements but will require further discussions with the proponents to determine the exact dimensions of consolidated easements.


We do also wish to stress that closure of the road reserve should not occur until the impact on overland stormwater flows is fully understood.



With reference to the image below and along Majara Street unless otherwise stated.

Sewer (red)

- can be abandoned as part of the works depending on what they are doing internally.
- As an alternative, ownership of the main can be transferred to DoE with a new pit to be provided at the northern boundary. All sewer from the school to fall to that new point.
- From the operational point of view, we really, really, really don't like having to go into Schools to deal with sewer issues. It's a whole different level of hurt for us around working with children, safe work, public health etc etc best if we don't have to be in there.

Stormwater (green)

- will need to be in an easement and new stormwater will need to come into the pit shown on the south-western corner of the Majara/Turallo intersection.
- The easement will also need to include restrictions to prevent the blocking of stormwater flows

Water (blue)

- can be in an easement, no structures to be built over it or within the zone of influence.
- We want a value at the northern/southern boundary for us to isolate that stretch as well.
- Water connection will need to come from a single offtake with the meter located on an accessible boundary (note, this will mean replumbing the connection to the current Council building). We will only have one master meter for the site and all submeters to come off this.
- Easement (or other appropriate instrument) to include words preventing any other connections to that main (to protect public health).

That's it for Majara Street itself. You will also see in the image above two connections coming into Mick Sherd Oval from the north (one purple, one blue). As I am not completely aware of what the arrangements will be, if the reserve is not in Council ownership/management, we will need an easement registered over the underground tank (owned by the sewer fund) and the supply pipe (purple line and point 516) to provide access for maintenance. The blue line leading to point 492, if retained, would also need an easement. I am looking for any design/WAE plans we have for this tank.

Another matter that I would like to bring to your attention is the recycled water used on the field. We will need to consider who the recycled water end-user agreement will be with. We will either be entering into an end-user agreement with Urban Landscapes (i.e. Council) or DoE and it will also bind the other party. The agreement is required with end-users to satisfy our regulatory requirements. Basically, it's a mechanism that will allow Council to turn off recycled water if the agreement isn't being met.





