Work on the Ellerton Drive extension is progressing well with the project on track for completion by mid-2020.



Bridge construction progress

Work on the bridge has made significant progress with all piers now built, and five segments launched across the Queanbeyan River to date.

An additional bridge segment is expected to be launched each month until all nine segments are in place. The full bridge span is expected to connect to the southern side of the Queanbeyan River early next year.

Road construction and earthwork

Work is well underway to build the road pavement layers.

Bulk earthworks for the project are now substantially complete.

Upgrade of existing Ellerton Drive

Pavement upgrade work on the existing section of Ellerton Drive started in May and is expected to be completed in late September, weather permitting.

Landscaping work

Landscaping is underway to reduce dust generated on site with grass and mulch laid on embankments where work has been completed. Tree and shrub planting will start closer to the end of the project and will be regularly maintained.

Noise wall construction

Noise walls on existing Ellerton Drive and near Taylor Place have been completed.

Construction of noise walls in Fairlane Estate near the Queanbeyan River is more than 50 per cent complete. Work started near the river and will progress towards Old Cooma Road.
