Can Council please indicate which of the projects below are expected to be completed and which will not be completed in the 2021-22 financial year?

2. Further, can Council please indicate which of the projects above not to be completed in the 2021-22 financial year are expected to be carried over to the 2022-23 financial year and whether or not they are funded?

See Q1 above.

3. The State of Cooma / Krawaree Road has deteriorated significantly this year due to the wet weather to the extent that locals are advising occasional users that it is only suitable for 4WD vehicles. It is therefore encouraging that the draft Delivery Program for 2022-26 has \$1,117,000 allocated over 4 years to project 102012 (BWD - Cooma Rd/Krawaree Rd). This project had \$278,000 allocated to it in the 2021-22 Operational Plan, with no notes indicating that was subject to grant funding. However, the Delivery Program Update – July-December 2021 stated 'There is no capital works scheduled on Cooma/Krawaree Road funded from the Regional Road Block Grant this financial year' and described the work as 'Completed' as a result. Can Council please indicate which organisation made the decision not to fund these capital works and is Council in a position to provide any guarantees that funds indicated in the draft Delivery Program will actually be allocated to project 102012?

Council is continuing the reconstruction of Cooma Road between Jinglemoney Road and O'Briens Road. The Regional Roads Block Grant component in PJ102012 has be reallocated to PJ102073 to provide the 50% cost match for the Regional Roads Repair Program (RRRP) project.

In 2021/22, \$374,000 has been secured as part of the RRRP with an equal amount of \$374,000 being allocated from the Regional Road Block Grant. A submission to continue this project in 2022/23 has been made to Transport for NSW. If successful, an additional \$400,000 of RRRP funding and \$400,000 of Regional Road Block Grant will be allocated to continuing the reconstruction of Cooma Road.

4. Can Council please explain the difference between project 104370 and 100701 which both refer to the Lascelles Street upgrade?

There were originally two separate project numbers for Lascelles Street Upgrade to cover the two separate grant programs funding the project, as follows:

- 1) 100701 \$800k from Stronger Communities (part of the \$9m amalgamation funds)
- 2) 104370 \$400k from Local Road and Community Infrastructure

To avoid confusion on which project numbers to use when assigning costs, the 104370 project number was rolled into 100701.

5. Can Council please explain the difference between projects 100879, 104078 and 100972 which all refer to the Braidwood Office Refurbish & Smart Hub?

The 3 projects relate to the improvement of the Braidwood Office area and is considered as one project.

6. Can Council please explain what is involved in project 104645 (BWD - Pedestrian Refuge Lascelles-Monkittee) and why it is estimated to cost \$381,000 over 4 years, when the estimated cost in the Braidwood Bicycle and Pedestrian Facilities Plan was only \$25,000 for this facility and the reason why it is proposed to pursue this 'Medium' priority facility in advance of 'High' priority facilities?

Since the Braidwood Bicycle and Pedestrian Facilities Plan was developed, the town's chemist has relocated from the town centre to its current location on Lascelles Street. This has adjusted pedestrian movements through town and priorities.

Originally the project was only to include the installation of a refuge island.

As this part of Lascelles Street is a state-controlled road, Council is required to seek the approval of Transport for NSW (TfNSW) for any proposed work. The initial comments received from TfNSW is to ensure lighting of the refuge island meet standards. The inclusion of streetlights into the design and construction has increased the required budget for the refuge island considerably.

7. Can Council please explain what is involved in project 104646 (BWD - Pedestrian Refuge Lascelles – Elrington) and why it is estimated to cost \$410,000 over 4 years, when the estimated cost in the Braidwood Bicycle and Pedestrian Facilities Plan was only \$25,000 for this facility and the reason why it is proposed to pursue this 'Medium' priority facility in advance of 'High' priority facilities?

Since the Braidwood Bicycle and Pedestrian Facilities Plan was developed, the town's skatepark has been identified to go into the Braidwood Recreational Ground and the grounds will also

receive upgrades. These works will generate more pedestrian movements across this part of Lascelles Street and change priorities.

Originally the project was only to include the installation of a refuge island.

As this part of Lascelles Street is a state-controlled road, Council is required to seek the approval of Transport for NSW (TfNSW) for any proposed work. The initial comments received from TfNSW is to ensure lighting of the refuge island meet standards. The inclusion of streetlights into the design and construction has increased the required budget for the refuge island considerably.

8. Can Council please provide the latest Water Funds Quarterly Budget Review Statement for the Palerang Water Fund for the period 2021–22 and the initial estimate for the Period 2022–23?

This matter is currently being reviewed with the intention of presentation to the 25 May Ordinary Meeting of Council. Further details can be provided after endorsement by Council.

9. Can Council please provide the annual revenue for Sec.64 water developer charges for Palerang for the years from 2015-16 through to 2021-22 to date?
