Recitals

- A. The parties have entered into a Memorandum of Understanding as amended by a Memorandum of Understanding Addendum and a Deed of Agreement which amongst other things provides for the provision of community and club facilities amenities by the Club.
- B. The parties have agreed to vary the Memorandum of Understanding, in accordance with the terms and conditions of this deed.

This deed witnesses that in consideration of, among other things, the mutual promises contained in this deed the parties agree as follows:

1. Definitions and interpretation clauses

1.1 Definitions

In this deed, unless the context otherwise requires or permits:

Deed of Agreement	means the document titled Deed of Agreement between the parties dated 6 July 2022.
Memorandum of Understanding	means the document titled memorandum of understanding between the parties dated 4 July 2016 as varied and supplemented by the Memorandum of Understanding Addendum.
Memorandum of Understanding Addendum	means the document titled memorandum of understanding addendum between the parties dated 10 December 2019 which varied the terms of the Memorandum of Understanding.

1.2 Interpretation

All terms defined in the Memorandum of Understanding which are not separately defined in this deed will have the same meaning when used in this deed.

2. Variation of MOU

The Council, Club and Googong Township agree to vary the Memorandum of Understanding as follows:

- (a) Clause 2.2 is amended by adding at the end of the existing clause the following.
'In the event that clause 2.1(b) is not satisfied the Developer may by written notice to the Club and Council terminate this Memorandum of Understanding'.
- (b) Clause 3.3 is amended by deleting '31 January 2024' and replacing it with '31 January 2025'.

3. Counterparts and Electronic Signature

3.1 Execution of Deed

This deed may be executed:

- (a) in any number of counterparts and all the counterparts together make one instrument; and/or

- (b) electronically by exchanging electronic copies of original signatures on this deed.

3.2 Validity of Deed

- (a) This deed may be validly created and exchanged by counterparts with each party's signature (electronic or otherwise) sent electronically to each other party by email or facsimile.
- (b) The parties acknowledge that the electronic version of this deed signed by both parties will be the true and original version for the purposes of this transaction and that no other version will be provided unless otherwise agreed between the parties in writing.
- (c) The parties agree to be bound by the electronic version of this deed which has been signed and exchanged in accordance with this clause.

3.3 Compliance with Electronic Transaction Act 2000 (NSW)

The parties agree that they will be bound by, have complied with and will comply with the *Electronic Transactions Act 2000* (NSW), in relation to the execution of this deed.

4. Amendment of this Deed

This deed may only be amended or supplemented in writing signed by the parties.

5. Costs

Each party agrees to pay its own costs in connection with the preparation, negotiation and execution of this deed.

6. Further assurances

Each party must, at its own expense, do all things and execute all further documents necessary to give full effect to this deed and the transactions contemplated by it.

Dear Councillor Winchester *Kenrick,*

Thank you for your letter regarding Tallaganda State Forest and Southern Greater Gliders. I appreciate you bringing this matter to my attention.

As you are aware, on 31 August 2023, the NSW Environment Protection Authority (EPA) issued a Stop Work Order (SWO) to the Forestry Corporation of NSW (FCNSW) to cease harvesting operations in Tallaganda State Forest. The EPA has subsequently extended the SWO.

While the SWO is in place, the EPA is investigating a number of alleged breaches of the Coastal Integrated Forestry Operations Approval. As the investigation is ongoing, it would be inappropriate for me to make further comment.

If you have any further questions about this issue, please contact Mr Steve Orr, A/Executive Director, Operations, EPA on [REDACTED].

Thank you for taking the time to bring this matter to the Government's attention.

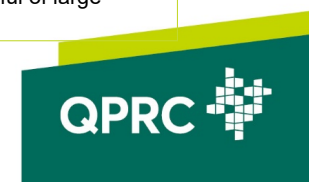

5. Business Items

a) **LTC 32/2023 – Queanbeyan Community Christmas Party & Carols (Revised)**

Introduction/Background:

Queanbeyan-Palerang Regional Council intend to host, for the first time, the combined Queanbeyan Community Christmas Party & Carols on Saturday 16th December 2023 in the Queanbeyan Park, between Campbell Street and Lowe Street, Queanbeyan.

It is estimated more than 2,000 people will attend across the duration of the event.

The proposal is to close Campbell Street between Meredith Street and Park Street. The closure will take place between 1:30pm and 9:30pm with the event taking place between 3:00pm and 9:00pm.

LTC Comments:

Voting members questioned whether emergency vehicle access would be available along Campbell Street if required which was confirmed. Voting members wished to confirm that residents in the closed streets would have access to their properties which was confirmed. Voting members also noted that this event requires the presence of Parking Rangers due to historical non-compliance with events in this area. QPRC Events confirmed that Parking Rangers will be onsite and also advised that parking will be available from the Showground. Pedestrians are to exit the showground on to Lowe Street and walk to the event along Lowe Street, gates on Farrer Place will be closed. Voting members also noted that the detour signage on the TMP does not complete the route, this is to be amended. Supported provided amendment to detour signage.

LTC32/2023 – Proposed Solution: Under Roads Act 1993, approve the proposed road closure for Queanbeyan Community Christmas Party & Carols, with amendment to TMP.

b) LTC 34/2023 – Braidwood Community Christmas Party & Shop’N’Win Event (Revised)

Introduction/Background:

QPRC Events and Placement teams are working with the Braidwood Community to host the Braidwood Community Christmas Party and Shop’N’Win Event on Thursday 14th December 2023 in the National Theatre on Wallace Street and Duncan Street.

It is estimated that up to 1,000 people will attend the event.

The proposal is to close a small section of Duncan Street on the western side of Wallace Street, as per the TMP. The closure will take place between 4:00pm and 9:30pm with the event taking place between 5:00pm and 8:00pm.

LTC Comments:

Misinformation in the report that identifies a closure on Wallace Street, confirming the closure is Duncan Street only. Minimal impact on local traffic, detour signs not required. Voting member questioned the allocated parking for the event. Confirmed that due to the event being afterhours on Thursday, adequate parking will be available on Wallace Street. Event Supported.

LTC 34/2023 – Proposed Solution: Under Roads Act 1993, approve the proposed road closure for the Braidwood Community Christmas Party & Shop’N’Win Event.

c) Event: Braidwood Car & Bike Show

Introduction/Background:

Braidwood Car and Bike Show is planned for Saturday 20th January 2024. This is a family friendly event, showcasing cars and bikes old and new. Aside from the automotive display there will be kids’ activities, market stalls and food.

The proposed road closure is for Park Lane. The closure is expected to be between 7:00am and 5:00pm.

LTC Comments:

TMP remains the same from previous years. Expected vehicles has increased to 100 vehicles, QPRC events to ensure event organisers are aware that once the nominated area is full, additional cars are to use parking areas as per regular patrons.

NSW Police noted they will not be subject to the condition listed on bottom of page 56; “But will make every effort to inform other agencies of the nature of the incident and the police response.”

Voting members also requested that Emergency Services, the School, 145 Park Lane and the Royal Mail Hotel are contacted, and their access is not restricted throughout the event.

Voting members noted that if there are effects to Wallace Street, an ROL will be required.



Event Supported.

LTC 39/2023 – Proposed Solution: Under Roads Act 1993, approve the temporary traffic control measures as detailed in TCP for Braidwood Car & Bike Show.

d) Event: Music by the River

Introduction/Background:

Music by the River, a QPRC signature event, is schedule for Saturday evening 4th February from 4:00pm to 9:00pm. This event has various guest appearances followed by a repertoire from the Canberra Symphony Orchestra to fill out the evening.

Last years event had an attendance of 2300 people.

The proposed road closure is along Morisset Street from Carinya Street to Collett Street and Collett Street from Morisset Street to the Coles carpark entrance.

LTC Comments:

Noted that this TMP is to match the TMP from the Diwali event which was successful and worked well. Voting member noted that the plan provided in the submission was not the approved plan for Diwali and was an earlier plan which has since been amended. Voting member noted that SES should be notified to be available to monitor river access or accidental entry. Voting member requested that the unit block on Morisset Street is to be notified of road closures.

Event supported.

LTC 40/2023 – Proposed Solution: Under Roads Act 1993, approve the amended Traffic Control Plan for the Music by the River event.

e) Event: Tarago Road – Line Marking Changes

Introduction/Background:

Queanbeyan-Palerang Regional Council has received complaints from residents and staff that vehicles are overtaking near the Bungendore Waste Transfer Station. This is creating a near miss as vehicles turn right into the station and cars behind are coming around to overtake. Tarago Road is currently line marked with a BL1 line, so in this instance cars should not be overtaking in this area. However, the current line marking is very faded and non-compliant. In addition to this, the sight distance also does not comply due to the installation of the roundabout for Elm Grove.

Proposed new line marking for approx. 1.1km of Tarago Road with BL1, BL2 and DL1 as per attached plans.

LTC Comments:

Supported.

LTC 41/2023 – Proposed Solution: Under Roads Act 1993, approve the changed line marking for Tarago Road.

6. General Business

Queanbeyan-Palerang Regional Council noted they are still working with organisers of Goofest and Queanbeyan Rodeo, they will send out discussion items prior to next meeting.

c) Other

Indigo Braeder (MoP Rep) asked on the process with adding agenda items. Indigo Braeder shared questions from constituents in relation to Speed on Brudenell, a Wombat Crossing on Firethorn and change in speed for Edwin Land Parkway which Jacky Woolhouse advised were already being looked at by QPRC.
