1. When did Council approve the name "Woolark Road", off Hoskinstown Road, Bungendore?

#### Response by: Development and Environment

Council has not approved the name ‘Woolark Road’, off Hoskinstown Road, Bungendore.

Instead, the name ‘Bunduluk Road’ was presented to the 14 June 2023 Council meeting and it was resolved to:

1. adopt in principle the name; Bunduluk Road, Bungendore, created under subdivision development consent DA.2019.1255 Condition #57.
2. Advertise the proposed road name for public comment for 28 days.
3. Publish a notice in the NSW Government Gazette for the road name Bunduluk Road if no objections received.
