4 'Questions on Notice' from the Public

Responses to the following 'Questions on Notice' received up to *Wednesday 21 October 2020* were provided and tabled at the meeting

Questions submitted by: Chris Pritzler

1. QUEANBEYAN RIVERSIDE TOURIST PARK LEASE OBJECTION. The Objection lodged with QPRC regarding the proposed lease of the Queanbeyan Riverside Tourist Park has not been acknowledged by QPRC. Has the matter been forwarded to the relevant NSW Government Minister for Determination of this Objection as stated in QPRC documentation?

Response – Organisation Capability

Council is required to consider all submissions duly provided and refer the matter to the Minister if an objection is received during the submission period.

The submission period for the proposed lease opened 27 July until 24 August 2020. Council did receive a submission on 14 August requesting information and a response from Council was provided on 27 August. The matters raised in that request had been accommodated in the updated community map for the park. A formal objection was submitted on 28 August outside the submission period and has not been forwarded to the Minister.

The writer has received correspondence from Council confirming the same.
